# Combinatorial Hopf algebras and generalized Dehn-Sommerville relations

#### Abstract

A combinatorial Hopf algebra is a graded connected Hopf algebra over a field $\mathbb{k}$ equipped with a character (multiplicative linear functional) $\zeta: \mathcal{H} \rightarrow \mathbb{k}$. We show that the terminal object in the category of combinatorial Hopf algebras is the algebra $\mathcal{Q}$ Sym of quasisymmetric functions; this explains the ubiquity of quasi-symmetric functions as generating functions in combinatorics. We illustrate this with several examples. We prove that every character decomposes uniquely as a product of an even character and an odd character. Correspondingly, every combinatorial Hopf algebra ( $\mathcal{H}, \zeta$ ) possesses two canonical Hopf subalgebras on which the character $\zeta$ is even (respectively, odd). The odd subalgebra is defined by certain canonical relations which we call the generalized Dehn-Sommerville relations. We show that, for $\mathcal{H}=\mathcal{Q}$ Sym, the generalized Dehn-Sommerville relations are the Bayer-Billera relations and the odd subalgebra is the peak Hopf algebra of Stembridge. We prove that $\mathcal{Q S y m}$ is the product (in the categorical sense) of its even and odd Hopf subalgebras. We also calculate the odd subalgebras of various related combinatorial Hopf algebras: the Malvenuto-Reutenauer Hopf algebra of permutations, the LodayRonco Hopf algebra of planar binary trees, the Hopf algebras of symmetric functions and of non-commutative symmetric functions.

## Introduction

A combinatorial Hopf algebra is a pair $(\mathcal{H}, \zeta)$ where $\mathcal{H}=\bigoplus_{n \geqslant 0} \mathcal{H}_{n}$ is a graded connected Hopf algebra over a field $\mathbb{k}$ and $\zeta: \mathcal{H} \rightarrow \mathbb{k}$ is a character (multiplicative linear functional), called its zeta function. A morphism $\alpha:\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right) \rightarrow(\mathcal{H}, \zeta)$ of combinatorial Hopf algebras is a morphism of

graded Hopf algebras such that $\zeta^{\prime}=\zeta \circ \alpha$. The terminal object in the category of combinatorial Hopf algebras is the algebra $\mathcal{Q}$ Sym of quasi-symmetric functions, equipped with a canonical character $\zeta_{\mathcal{Q}}: \mathcal{Q}$ Sym $\rightarrow \mathbb{k}$ (Theorem 4.1). This theory provides a natural framework for combinatorial invariants encoded via quasi-symmetric generating functions.

The algebra $\mathcal{Q}$ Sym of quasi-symmetric functions was introduced by Gessel [Ges84] as a source of generating functions for poset partitions (Stanley's $P$-partitions [Sta72]). The algebra Sym of symmetric functions is a subalgebra of $\mathcal{Q S y m}$. The graded dual of $\mathcal{Q S y m}$ is the Hopf algebra $\mathcal{N S y m}$ of non-commutative symmetric functions [MR95, GKLLRT95].

Joni and Rota [JR79] made the fundamental observation that many discrete structures give rise to natural Hopf algebras whose comultiplications encode the disassembly of those structures. This was further developed by Schmitt [Sch87, Sch94]. A first link between these Hopf algebras and quasi-symmetric functions was found by Ehrenborg [Ehr96], who encoded the flag vector of a graded poset as a morphism from a Hopf algebra of graded posets to $\mathcal{Q S y m}$. A similar construction was given in [BS99], where it was shown that a quasi-symmetric function associated to an edge-labeled poset also gives a morphism of Hopf algebras. Such quasi-symmetric functions encode the structure of the cohomology of a flag manifold as a module over the ring of symmetric functions [BS98, BS02]. These results were later unified via the notion of Pieri operations on posets [BMSW00, BMSW02]. In Examples 4.4-4.6 we show how all these constructions can be obtained from Theorem 4.1 in a very natural manner.

A closely related result to Theorem 4.1 was obtained in [Agu02]. There, the terminal object in the category of infinitesimal Hopf algebras (equipped with a multiplicative functional) was described. Here, we adapt and expand the constructions of [Agu02], including the notions of Eulerian subalgebra (here called odd subalgebra) and generalized Dehn-Sommerville relations.

We review the contents of the paper.
We start by discussing the group of characters of a graded connected Hopf algebra in § 1. Our first main result (Theorem 1.5) states that any character decomposes uniquely as a product of an even character and an odd character. Even and odd characters are defined in terms of the involution $\bar{h}:=(-1)^{|h|} h$ of a graded connected Hopf algebra (Definition 1.2).

In § 2 we introduce the notion of combinatorial Hopf algebras $(\mathcal{H}, \zeta)$. Associated to the character $\zeta$ are certain canonical characters $\chi$ and $\nu$; these are closely related to the decomposition of $\zeta$ as a product of an even and an odd character. We present some combinatorial Hopf algebras involving partially ordered sets in Examples 2.2-2.4, and we describe the combinatorial meaning of the canonical characters in each case.

We recall the definitions of the Hopf algebras of quasi-symmetric functions and non-commutative symmetric functions in §3. This short section sets the notation to be used later in the paper, but it contains no new results and may be skipped by the reader familiar with these notions.

In $\S 4$ we introduce the character $\zeta_{\mathcal{Q}}: \mathcal{Q}$ Sym $\rightarrow \mathbb{k}$ and obtain the following universal property, which is our second main result (Theorem 4.1):

For any combinatorial Hopf algebra $(\mathcal{H}, \zeta)$, there is a unique morphism of combinatorial Hopf algebras $\Psi:(\mathcal{H}, \zeta) \rightarrow\left(\mathcal{Q}\right.$ Sym,$\left.\zeta_{\mathcal{Q}}\right)$.
Thus, $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$ is the terminal object in the category of combinatorial Hopf algebras. We also show that the Hopf algebra of symmetric functions, equipped with the restriction $\zeta_{S}$ of $\zeta_{\mathcal{Q}}$, is the terminal object in the category of cocommutative combinatorial Hopf algebras (Theorem 4.3). We illustrate these results with several examples of a combinatorial nature, including the flag vector of posets and the chromatic symmetric function of graphs (Examples 4.4-4.6 and 4.7-4.9). We also show that the morphism $\mathcal{Q S y m} \rightarrow \mathcal{Q}$ Sym corresponding to the character $\nu_{\mathcal{Q}}$ is the map introduced by Stembridge in [Ste97]. Other examples will be presented in [Agu05].

## Combinatorial Hopf algebras

There are two Hopf subalgebras of $\mathcal{H}$ canonically associated to $\zeta$. They are the largest subcoalgebras on which $\zeta$ is even or odd. The definitions and basic properties of these objects are presented in §5. The odd subalgebra is defined by certain linear relations which we call the generalized Dehn-Sommerville relations for $(\mathcal{H}, \zeta)$. For a homogeneous element $h \in \mathcal{H}$ these relations are

$$
\left(\mathrm{id} \otimes\left(\bar{\zeta}-\zeta^{-1}\right) \otimes \mathrm{id}\right) \circ \Delta^{(2)}(h)=0,
$$

or equivalently

$$
(\mathrm{id} \otimes(\chi-\epsilon) \otimes \mathrm{id}) \circ \Delta^{(2)}(h)=0
$$

We show that the generalized Dehn-Sommerville relations for $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$ are precisely the relations of Bayer and Billera [BB85] (Example 5.10).

The construction of even and odd subalgebras is natural: a morphism $\alpha:\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right) \rightarrow(\mathcal{H}, \zeta)$ of combinatorial Hopf algebras sends the even (odd) subalgebra of $\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right)$ to the even (odd) subalgebra of $(\mathcal{H}, \zeta)$ (Propositions 5.6 and 5.8). Following [Agu02], we show how this simple fact implies the important result of Bayer and Billera that the flag vector of an Eulerian poset satisfies the generalized Dehn-Sommerville relations (of $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$ ). First, it is well known that one may construct a certain combinatorial Hopf algebra $(\mathcal{R}, \zeta)$ from graded posets so that $\zeta$ and $\zeta^{-1}$ are the usual zeta and Möbius functions of posets [JR79, Sch94]. We add the observation that all Eulerian posets belong to the odd subalgebra of $(\mathcal{R}, \zeta)$. By naturality, the flag vector of an Eulerian poset must belong to the odd subalgebra of $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$, and thus satisfy the generalized Dehn-Sommerville relations.

In § 6 we describe the even and odd subalgebras of $\left(\mathcal{Q}\right.$ Sym,$\left.\zeta_{\mathcal{Q}}\right)$ in explicit terms. These algebras have basis elements indexed by even and odd compositions, respectively. In particular, we find that the odd subalgebra is precisely the peak Hopf algebra of Stembridge [Ste97]. We show that these subalgebras are the terminal objects in the categories of even and odd combinatorial Hopf algebras (Corollary 6.2). We show that the morphisms $\mathcal{Q S y m} \rightarrow \mathcal{Q}$ Sym corresponding to the even and odd parts of $\zeta_{\mathcal{Q}}$ are projections onto these subalgebras (Proposition 6.8) and derive our third main result: that $\mathcal{Q S y m}$ is the categorical product of its even and odd Hopf subalgebras (Theorem 6.10). These results confirm the importance of Stembridge's Hopf algebra and at the same time unveil the mystery behind its construction.

In § 7 we describe the even and odd subalgebras of $\left(S y m, \zeta_{S}\right)$. These algebras have basis elements indexed by even and odd partitions. We find that the odd subalgebra is precisely the Hopf algebra of Schur $Q$-functions [Mac95, III.8.1].

In § 8 we describe the odd subalgebras of closely related Hopf algebras: the Hopf algebra of noncommutative symmetric functions, the Hopf algebra of permutations of Malvenuto and Reutenauer, and the Hopf algebra of planar binary trees of Loday and Ronco.

Assumption. Most of our results are valid over any commutative ring $\mathbb{k}$ in which 2 is invertible, but for simplicity we work over a base field $\mathbb{k}$ of characteristic different from 2 . The results in $\S 4$, however, are valid over any commutative ring. The assumption on the characteristic is recalled in the statement of some theorems, when emphasizing it seems necessary.

## 1. The group of characters of a graded connected Hopf algebra

Definition 1.1. Let $\mathcal{H}$ be a Hopf algebra over a field $\mathbb{k}$. A character of $\mathcal{H}$ is a morphism of algebras $\zeta: \mathcal{H} \rightarrow \mathbb{k}$. Thus $\zeta(a b)=\zeta(a) \zeta(b)$ and $\zeta(1)=1$. We also refer to characters as multiplicative linear functionals.

Recall that the convolution product of two linear functionals $\varphi, \psi: \mathcal{H} \rightarrow \mathbb{k}$ is

$$
\begin{equation*}
\mathcal{H} \xrightarrow{\Delta_{\mathcal{H}}} \mathcal{H} \otimes \mathcal{H} \xrightarrow{\varphi \otimes \psi} \mathbb{k} \otimes \mathbb{k} \xrightarrow{m_{\mathfrak{k}}} \mathbb{k} \tag{1.1}
\end{equation*}
$$

where $\Delta_{\mathcal{H}}$ is the coproduct of $\mathcal{H}$ and $m_{\mathbb{k}}$ is the product of the base field. We denote the convolution product simply by $\varphi \psi$. This turns the full linear dual of $\mathcal{H}$ into an algebra. Let $m_{\mathcal{H}}$ be the product of $\mathcal{H}$. Sweedler's dual $\mathcal{H}^{\circ}$ is the largest subspace of the full linear dual such that $m_{\mathcal{H}}^{*}\left(\mathcal{H}^{\circ}\right) \subseteq \mathcal{H}^{\circ} \otimes \mathcal{H}^{\circ}$. Equipped with the convolution product and the comultiplication $m_{\mathcal{H}}^{*}, \mathcal{H}^{\circ}$ is a Hopf algebra. A character $\varphi$ of $\mathcal{H}$ is precisely a group-like element of $\mathcal{H}^{\circ}: m_{\mathcal{H}}^{*}(\varphi)=\varphi \otimes \varphi$.

The set $\mathbb{X}(\mathcal{H})$ of characters of an arbitrary Hopf algebra $\mathcal{H}$ is a group under the convolution product. The unit element is the counit $\epsilon_{\mathcal{H}}$, and the inverse of a character $\varphi$ is $\varphi^{-1}:=\varphi \circ S_{\mathcal{H}}$, where $S_{\mathcal{H}}$ is the antipode of $\mathcal{H}$. In fact, using the antipode axiom and the fact that $\varphi$ is a morphism of algebras one finds

$$
\begin{aligned}
\varphi\left(\varphi \circ S_{\mathcal{H}}\right) & =m_{\mathbb{k}} \circ\left(\varphi \otimes\left(\varphi \circ S_{\mathcal{H}}\right)\right) \circ \Delta_{\mathcal{H}}=m_{\mathbb{k}} \circ(\varphi \otimes \varphi) \circ\left(\mathrm{id} \otimes S_{\mathcal{H}}\right) \circ \Delta_{\mathcal{H}} \\
& =\varphi \circ m_{\mathcal{H}} \circ\left(\mathrm{id} \otimes S_{\mathcal{H}}\right) \circ \Delta_{\mathcal{H}}=\varphi \circ u_{\mathcal{H}} \circ \epsilon_{\mathcal{H}}=u_{\mathrm{k}} \circ \epsilon_{\mathcal{H}}=\epsilon_{\mathcal{H}},
\end{aligned}
$$

where $u_{\mathcal{H}}$ and $u_{\mathbb{k}}$ are the unit maps of $\mathcal{H}$ and $\mathbb{k}$. Similarly, $\left(\varphi \circ S_{\mathcal{H}}\right) \varphi=\epsilon_{\mathcal{H}}$.
If $\mathcal{H}$ is cocommutative then $\mathbb{X}(\mathcal{H})$ is abelian.
A morphism of Hopf algebras $\alpha: \mathcal{H}^{\prime} \rightarrow \mathcal{H}$ induces a morphism $\alpha^{*}: \mathbb{X}(\mathcal{H}) \rightarrow \mathbb{X}\left(\mathcal{H}^{\prime}\right)$ defined on a character $\varphi$ of $\mathcal{H}$ by $\alpha^{*}(\varphi)=\varphi \circ \alpha$. Since $\alpha$ is a morphism of algebras, $\alpha^{*}(\varphi)$ is a character of $\mathcal{H}^{\prime}$, and since $\alpha$ is a morphism of coalgebras, $\alpha^{*}$ is a morphism of groups.

Any graded Hopf algebra $\mathcal{H}$ carries a canonical automorphism

$$
h \mapsto \bar{h}:=(-1)^{n} h
$$

for homogeneous elements $h \in \mathcal{H}_{n}$. This is an involution: $\overline{\bar{h}}=h$. Therefore, it induces an involution $\varphi \mapsto \bar{\varphi}$ on the character group of $\mathcal{H}$, with

$$
\bar{\varphi}(h)=(-1)^{n} \varphi(h) \quad \text { for } h \in \mathcal{H}_{n} .
$$

Definition 1.2. A character $\varphi$ of a graded Hopf algebra $\mathcal{H}$ is said to be even if

$$
\bar{\varphi}=\varphi
$$

and it is said to be odd if

$$
\bar{\varphi}=\varphi^{-1}
$$

The even characters form a subgroup of $\mathbb{X}(\mathcal{H})$ that we denote by $\mathbb{X}_{+}(\mathcal{H})$. The set $\mathbb{X}_{-}(\mathcal{H})$ of odd characters is a subgroup of $\mathbb{X}(\mathcal{H})$ if $\mathcal{H}$ is cocommutative, but not in general.

Any morphism of graded Hopf algebras $\alpha: \mathcal{H}^{\prime} \rightarrow \mathcal{H}$ preserves the canonical involution; hence, the morphism of groups $\alpha^{*}: \mathbb{X}(\mathcal{H}) \rightarrow \mathbb{X}\left(\mathcal{H}^{\prime}\right)$ preserves even and odd characters.
Example 1.3. Let $\zeta$ be an arbitrary character of a graded Hopf algebra $\mathcal{H}$. There is a canonical way to construct an odd character from $\zeta$. Indeed, let

$$
\nu:=\bar{\zeta}^{-1} \zeta .
$$

As all these operations are defined on $\mathbb{X}(\mathcal{H}), \nu$ is a character. In addition,

$$
\bar{\nu}=\bar{\zeta}^{-1} \bar{\zeta}=\zeta^{-1} \bar{\zeta}=\nu^{-1}
$$

so $\nu$ is odd. This simple construction is of central importance for this work.
Define also

$$
\chi:=\bar{\zeta} \zeta .
$$

As before, $\chi$ is a character, and

$$
\bar{\chi}=\overline{\bar{\zeta}} \bar{\zeta}=\zeta \bar{\zeta} .
$$

If $\mathcal{H}$ is cocommutative then $\zeta \bar{\zeta}=\bar{\zeta} \zeta$, so $\chi$ is even.
In Remark 1.6 we interpret these constructions in terms of the group structure of $\mathbb{X}(\mathcal{H})$.

## Combinatorial Hopf algebras

From now on we assume that $\mathcal{H}$ is a graded connected Hopf algebra. Thus, $\mathcal{H}=\bigoplus_{n \geqslant 0} \mathcal{H}_{n}$, $\mathcal{H}_{0}=\mathbb{k} \cdot 1$, and all structure maps preserve the grading. We also assume that each $\mathcal{H}_{n}$ is finitedimensional. We reserve the notation $\mathcal{H}^{*}$ for the graded dual of $\mathcal{H}$. Thus, $\mathcal{H}^{*}=\bigoplus_{n \geqslant 0}\left(\mathcal{H}_{n}\right)^{*}$. It is a Hopf subalgebra of Sweedler's dual $\mathcal{H}^{\circ}$. Given a linear functional $\varphi: \mathcal{H} \rightarrow \mathbb{k}$ we set

$$
\varphi_{n}:=\left.\varphi\right|_{\mathcal{H}_{n}} \in \mathcal{H}_{n}^{*} .
$$

Since the comultiplication of $\mathcal{H}$ preserves the grading, we have

$$
\begin{equation*}
(\varphi \psi)_{n}=\sum_{i=0}^{n} \varphi_{i} \psi_{n-i} . \tag{1.2}
\end{equation*}
$$

Any character $\zeta$ satisfies $\zeta_{0}=\epsilon$. Note also that, if $\operatorname{char}(\mathbb{k}) \neq 2, \zeta$ is even if and only if $\zeta_{2 n+1}=0$ for all $n \geqslant 0$. An odd character, on the other hand, may have no zero components.

We set out to show that any character decomposes uniquely as a product of an even character and an odd character.

Proposition 1.4. Let $\mathcal{H}$ be a graded connected Hopf algebra over a field $\mathbb{k}$ of characteristic different from 2. Let $\varphi, \psi: \mathcal{H} \rightarrow \mathbb{k}$ be two linear functionals such that $\varphi_{0}=\psi_{0}=\epsilon$.
(a) There is a unique linear functional $\rho: \mathcal{H} \rightarrow \mathbb{k}$ such that

$$
\begin{equation*}
\varphi=\rho \psi \rho \quad \text { and } \quad \rho_{0}=\epsilon . \tag{1.3}
\end{equation*}
$$

(b) If $\varphi$ and $\psi$ are characters then so is $\rho$.
(c) If $\bar{\varphi}=\psi^{-1}$ then $\rho$ is even and if $\bar{\varphi}=\psi$ then $\rho$ is odd.

Proof. According to (1.2) to construct $\rho$ we must solve the following equations in $\mathcal{H}^{*}$, for each $n \geqslant 1$ :

$$
\varphi_{n}=2 \rho_{n}+\psi_{n}+\sum_{\substack{i+j+k=n \\ 0 \leqslant i, j, k<n}} \rho_{i} \psi_{j} \rho_{k} .
$$

Since 2 is invertible, these equations have a unique solution $\rho_{n}$, constructed recursively from $\rho_{0}=\epsilon$. This proves part (a).

From (1.3) we deduce

$$
\varphi \otimes \varphi=(\rho \otimes \rho)(\psi \otimes \psi)(\rho \otimes \rho),
$$

an equation between linear functionals on $H \otimes H$. Suppose now that $\varphi$ and $\psi$ are characters. As explained above, $m_{\mathcal{H}}^{*}(\varphi)=\varphi \otimes \varphi$ and $m_{\mathcal{H}}^{*}(\psi)=\psi \otimes \psi$. Therefore, applying the morphism of algebras $m_{\mathcal{H}}^{*}$ to (1.3) we obtain

$$
\varphi \otimes \varphi=m_{\mathcal{H}}^{*}(\rho)(\psi \otimes \psi) m_{\mathcal{H}}^{*}(\rho) .
$$

From the uniqueness of such decompositions established in part (a) (applied to the Hopf algebra $H \otimes H)$ we deduce

$$
m_{\mathcal{H}}^{*}(\rho)=\rho \otimes \rho .
$$

Thus, $\rho$ is a character, proving part (b).
Finally, suppose that $\bar{\varphi}=\psi^{-1}$. We have

$$
\varphi=\rho \psi \rho \Rightarrow \psi^{-1}=\bar{\varphi}=\bar{\rho} \bar{\psi} \bar{\rho} \Rightarrow \psi=(\bar{\rho})^{-1}(\bar{\psi})^{-1}(\bar{\rho})^{-1}=(\bar{\rho})^{-1} \varphi(\bar{\rho})^{-1} \Rightarrow \bar{\rho} \psi \bar{\rho}=\varphi .
$$

By uniqueness, $\rho=\bar{\rho}$, i.e. $\rho$ is even. The remaining half of part (c) can be derived similarly.
The following is the main result of this section.

Theorem 1.5. Let $\mathcal{H}$ be a graded connected Hopf algebra over a field $\mathbb{k}$ of characteristic different from 2. Every character $\zeta: \mathcal{H} \rightarrow \mathbb{k}$ decomposes uniquely as a product of characters

$$
\zeta=\zeta_{+} \zeta_{-}
$$

with $\zeta_{+}$even and $\zeta_{-}$odd. In particular, the only character that is both even and odd is the trivial one (the counit).
Proof. Proposition 1.4 allows us to define an even character $\zeta_{+}$such that

$$
\begin{equation*}
\bar{\zeta}=\zeta_{+} \zeta^{-1} \zeta_{+} \tag{1.4}
\end{equation*}
$$

Let $\zeta_{-}:=\left(\zeta_{+}\right)^{-1} \zeta$. By construction, $\zeta=\zeta_{+} \zeta_{-}$, and

$$
\bar{\zeta}_{-}=\left(\bar{\zeta}_{+}\right)^{-1} \bar{\zeta}=\left(\zeta_{+}\right)^{-1}\left(\zeta_{+} \zeta^{-1} \zeta_{+}\right)=\zeta^{-1} \zeta_{+}=\left(\zeta_{-}\right)^{-1}
$$

so $\zeta_{-}$is odd. This shows existence.
Consider another decomposition $\zeta=\varphi \psi$ with $\varphi$ even and $\psi$ odd. Then,

$$
\bar{\zeta}=\bar{\varphi} \bar{\psi}=\varphi \psi^{-1}
$$

while

$$
\varphi \zeta^{-1} \varphi=\varphi \psi^{-1} \varphi^{-1} \varphi=\varphi \psi^{-1}
$$

Thus, $\bar{\zeta}=\varphi \zeta^{-1} \varphi$. By uniqueness of such decompositions (Proposition 1.4) we must have $\varphi=\zeta_{+}$, and then also $\psi=\varphi^{-1} \zeta=\zeta_{-}$.
Remark 1.6. The canonical characters $\nu$ and $\chi$ of Example 1.3 are related to the decomposition of Theorem 1.5 as follows:

$$
\nu=\left(\zeta_{-}\right)^{2} \text { and, if } H \text { is cocommutative, } \chi=\left(\zeta_{+}\right)^{2} .
$$

Indeed, taking inverses on both sides of (1.4) we obtain $\bar{\zeta}^{-1}=\left(\zeta_{+}\right)^{-1} \zeta\left(\zeta_{+}\right)^{-1}$ and then

$$
\left(\zeta_{-}\right)^{2}=\left(\zeta_{+}\right)^{-1} \zeta\left(\zeta_{+}\right)^{-1} \zeta=\bar{\zeta}^{-1} \zeta=\nu,
$$

by definition of $\nu$. If $H$ is cocommutative then (1.4) becomes $\bar{\zeta}=\left(\zeta_{+}\right)^{2} \zeta^{-1}$, which by definition of $\chi$ says that $\chi=\left(\zeta_{+}\right)^{2}$.

Theorem 1.5 is complemented by the following result.
Proposition 1.7. Let $\mathcal{H}$ and $\mathbb{k}$ be as above. Then $\mathbb{X}_{-}(\mathcal{H})$ is a set of representatives for both the left and the right cosets of the subgroup $\mathbb{X}_{+}(\mathcal{H})$ of $\mathbb{X}(\mathcal{H})$. Moreover:
(a) $\mathbb{X}_{-}(\mathcal{H})$ is closed under conjugation by elements of $\mathbb{X}_{+}(\mathcal{H})$;
(b) if $\varphi, \psi \in \mathbb{X}_{-}(\mathcal{H})$ and $\varphi \psi=\psi \varphi$, then $\varphi \psi \in \mathbb{X}_{-}(\mathcal{H})$;
(c) $\mathbb{X}_{-}(\mathcal{H})$ is closed under integer powers, in particular under inversion.

Proof. Let us first derive parts (a)-(c). If $\zeta=\varphi \psi \varphi^{-1}$ with $\varphi$ even and $\psi$ odd, then

$$
\bar{\zeta}=\bar{\varphi} \bar{\psi}(\bar{\varphi})^{-1}=\varphi \psi^{-1} \varphi^{-1}=\zeta^{-1}
$$

so $\zeta$ is odd. This is part (a).
Suppose $\varphi, \psi$ are odd and $\zeta=\varphi \psi$. Then

$$
\bar{\zeta}=\bar{\varphi} \bar{\psi}=\varphi^{-1} \psi^{-1} .
$$

If $\varphi \psi=\psi \varphi$ then $\bar{\zeta}=\zeta^{-1}$, proving part (b). Part (c) follows from part (b).
Theorem 1.5 says that $\mathbb{X}_{-}(\mathcal{H})$ is a set of representatives for the left cosets of the subgroup $\mathbb{X}_{+}(\mathcal{H})$. Either part (a) or part (c) imply that the same holds true for the right cosets. For instance, $\zeta=\left(\zeta_{+} \zeta_{-}\left(\zeta_{+}\right)^{-1}\right) \zeta_{+}$displays $\zeta$ as a product of an odd character on the left with an even one on the right.

Combinatorial Hopf algebras
Corollary 1.8. Let $\mathcal{H}$ and $\mathbb{k}$ be as above. Suppose in addition that $\mathcal{H}$ is cocommutative. Then the group of characters splits as a direct product of abelian groups

$$
\mathbb{X}(\mathcal{H}) \cong \mathbb{X}_{+}(\mathcal{H}) \times \mathbb{X}_{-}(\mathcal{H})
$$

## 2. Combinatorial Hopf algebras

Definition 2.1. A combinatorial Hopf algebra is a pair $(\mathcal{H}, \zeta)$ where $\mathcal{H}$ is a graded connected Hopf algebra over a field $\mathbb{k}$ and $\zeta: \mathcal{H} \rightarrow \mathbb{k}$ is a character.

A morphism of combinatorial Hopf algebras $\alpha:\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right) \rightarrow(\mathcal{H}, \zeta)$ is a morphism $\alpha: \mathcal{H}^{\prime} \rightarrow \mathcal{H}$ of graded Hopf algebras such that the following diagram commutes.


Combinatorial Hopf algebras over a field $\mathbb{k}$, together with their morphisms, form the category of combinatorial Hopf algebras over $\mathbb{k}$. Combinatorial algebras and coalgebras and their morphisms are defined similarly (in these cases, $\zeta$ is only required to be a linear functional).

We refer to $\zeta$ as the zeta character of the combinatorial Hopf algebra. We introduce the following terminology for the canonical characters associated to $\zeta$ (Example 1.3):

$$
\begin{aligned}
\zeta^{-1} & =\zeta \circ S_{\mathcal{H}} \text { is the Möbius character, } \\
\chi & =\bar{\zeta} \zeta \text { is the Euler character, } \\
\nu & =\bar{\zeta}^{-1} \zeta \text { is the odd character. }
\end{aligned}
$$

The terminology is motivated by Example 2.2 below.
Example 2.2 (Rota's Hopf algebra). Let $\mathcal{R}$ be the $\mathbb{k}$-vector space with basis the set of all isomorphism classes of finite graded posets. We say that a finite poset $P$ is graded if it possesses a maximum element $1_{P}$ and a minimum element $0_{P}$, and all maximal chains in $P$ have the same length. The rank of $P$, denoted $\operatorname{rk}(P)$, is the length of a maximal chain from $0_{P}$ to $1_{P}$. The space $\mathcal{R}$ is a graded connected Hopf algebra where the degree of $P$ is its rank, the multiplication is Cartesian product of posets

$$
P \cdot Q:=P \times Q,
$$

the unit element is the poset with one element, the comultiplication is

$$
\Delta(P):=\sum_{0_{P} \leqslant z \leqslant 1_{P}}\left[0_{P}, z\right] \otimes\left[z, 1_{P}\right],
$$

and the counit is

$$
\epsilon(P):= \begin{cases}1 & \text { if } 0_{P}=1_{P} \\ 0 & \text { otherwise }\end{cases}
$$

Here, and in everything that follows, if $x$ and $y$ are two elements of a poset $P$ then $[x, y]$ denotes the subposet $\{z \in P \mid x \leqslant z \leqslant y\}$.

This Hopf algebra originated in the work of Joni and Rota [JR79]. Variations of this construction have appeared repeatedly in the literature [AFS00, Ehr96, Sch94]. Here, we add the perspective of combinatorial Hopf algebras.

Let $\zeta: \mathcal{R} \rightarrow \mathbb{k}$ be $\zeta(P)=1$ for every poset $P$. This is the zeta function of posets in the sense of Rota [Rot64]. Clearly, $\zeta$ is a morphism of algebras, so $(\mathcal{R}, \zeta)$ is a combinatorial Hopf algebra.

It follows that the Möbius character $\zeta^{-1}$ is the classical Möbius function $\mu$ of posets, in the sense that

$$
\zeta^{-1}(P)=\mu\left(\left[0_{P}, 1_{P}\right]\right)
$$

is the value of the Möbius function of the poset $P$ on the interval $\left[0_{P}, 1_{P}\right]$. In fact, from $\zeta^{-1} \zeta=\epsilon$ we deduce the defining recursion for the Möbius function:

$$
\zeta^{-1}([x, x])=1 \text { for every } x \in P \text { and } \sum_{x \leqslant z \leqslant y} \zeta^{-1}([x, z])=0 \text { for every } x<y \text { in } P .
$$

This approach to Möbius functions of posets is due to Schmitt [Sch94].
Consider the Euler character $\chi$. We have

$$
\chi(P)=\sum_{z \in P}(-1)^{\mathrm{rk}\left[0_{P}, z\right]}=\sum_{i=0}^{n}(-1)^{i} f_{i}(P)
$$

where $n=\operatorname{rk}(P)$ and $f_{i}(P)$ is the number of elements of $P$ of rank $i$ (the ordinary $f$-vector). Suppose that $K$ is a finite cell complex of dimension $n-2$ and let $P$ be the poset of non-empty faces of $K$, with a bottom element and a top element adjoined. Then, for $1 \leqslant i \leqslant n-1, f_{i}(P)$ is the number of faces of $K$ of dimension $i-1$, and

$$
\chi(P)=1+(-1)^{n}-\sum_{i=1}^{n-1}(-1)^{i-1} f_{i}(P)
$$

is the Euler characteristic of a sphere of dimension $n-2$ (or $n$ ) minus the Euler characteristic of $K$.
Consider the class of graded posets $P$ for which

$$
(\chi-\epsilon)(P)=\left(\bar{\zeta}-\zeta^{-1}\right)(P) .
$$

This includes the graded poset of rank 0 (trivially) and all posets $P$ constructed from regular finite cell complexes as above. This follows from the above description of $\chi$, together with the fact that the Möbius function of $P$ is in this case the reduced Euler characteristic of $K$ [Sta97, Proposition 3.8.8].

Example 2.3. Let $\mathcal{P}$ be the $\mathbb{k}$-vector space with basis the set of all isomorphism classes of finite posets, not necessarily graded. The space $\mathcal{P}$ is a graded connected Hopf algebra where the degree of a poset $P$ is the number of elements of $P$, denoted \#P, the product is disjoint union of posets

$$
P \cdot Q:=P \sqcup Q,
$$

the unit element is the poset with no elements, and the coproduct is

$$
\Delta(P):=\sum_{I \leqslant P} I \otimes(P \backslash I) .
$$

Here, $I \leqslant P$ indicates that $I$ is a lower ideal of $P$, i.e. if $x \in P, y \in I$ and $x \leqslant y$ then $x \in I$. The subsets $I$ and $P \backslash I$ of $P$ are viewed as posets with the partial order of $P$. This Hopf algebra is implicit in the work of Gessel [Ges84] and Malvenuto [Mal94].

We turn $\mathcal{P}$ into a combinatorial Hopf algebra by defining $\zeta: \mathcal{P} \rightarrow \mathbb{k}$ by $\zeta(P)=1$ for every poset $P$. A poset is discrete if no two elements of $P$ are comparable. It follows that

$$
\zeta^{-1}(P)= \begin{cases}(-1)^{\# P} & \text { if } P \text { is discrete }  \tag{2.1}\\ 0 & \text { otherwise }\end{cases}
$$

In order to see this, note that a subset of $P$ is both discrete and a lower ideal if and only if it is a subset of $\operatorname{Min}(P)$, the set of minimal elements of $P$. Let $\mu(P)$ be the functional defined by the
right-hand side of (2.1). Then

$$
(\mu \zeta)(P)=\sum_{I \leqslant P} \mu(I)=\sum_{\substack{I \leqslant P \\ I \text { discrete }}}(-1)^{\# I}=\sum_{I \subseteq \operatorname{Min}(P)}(-1)^{\# I}= \begin{cases}1 & \text { if } \operatorname{Min}(P)=\emptyset \\ 0 & \text { otherwise }\end{cases}
$$

Now, any non-empty poset has a minimal element, so $\mu \zeta=\epsilon$ and $\mu=\zeta^{-1}$.
From (2.1) we deduce

$$
\bar{\zeta}^{-1}(P)= \begin{cases}1 & \text { if } P \text { is discrete } \\ 0 & \text { otherwise }\end{cases}
$$

Hence, the odd character is

$$
\nu(P)=\sum_{I \leqslant P} \bar{\zeta}^{-1}(I)=\sum_{\substack{I \leqslant P \\ I \text { discrete }}} 1=2^{\# \operatorname{Min}(P)} .
$$

Example 2.4. There is a canonical morphism of combinatorial Hopf algebras

$$
J:(\mathcal{P}, \zeta) \rightarrow(\mathcal{R}, \zeta)
$$

where $J(P)$ is the set of lower ideals of $P$, viewed as a poset under inclusion. The set $J(P)$ is a graded poset, with bottom element $\emptyset$, top element $P$, and rank function $\operatorname{rk}(I)=\# I$. The zeta characters are preserved trivially. Hence so are the other canonical characters.

It is known that $J(P)$ is in fact a distributive lattice, and that any distributive lattice is of this form for a unique poset $P$ [Sta97, Theorem 3.4.1]. Note also that if $P$ is discrete and $\# P=n$ then $J(P)=B_{n}$, the Boolean poset on $n$ elements (all subsets of $P$ ). Since the Möbius characters are preserved by $J$, we deduce from (2.1) that the Möbius function of a distributive lattice $L$ is

$$
\mu(L)= \begin{cases}(-1)^{n} & \text { if } J=B_{n} \\ 0 & \text { otherwise }\end{cases}
$$

In §4, the canonical characters of the combinatorial Hopf algebra of quasi-symmetric functions are calculated.

## 3. The Hopf algebras $\mathcal{Q}$ Sym and $\mathcal{N}$ Sym

This section recalls the Hopf algebraic structure of quasi-symmetric functions and of non-commutative symmetric functions. For more details, see [GKLLRT95, Haz03, Mal94, MR95, Sta99]. The reader familiar with these notions may skip ahead to $\S 4$.

A composition $\alpha$ of a positive integer $n$, written $\alpha \vDash n$, is an ordered list $\alpha=\left(a_{1}, a_{2}, \ldots, a_{k}\right)$ of positive integers such that $a_{1}+a_{2}+\cdots+a_{k}=n$. We let $k(\alpha):=k$ be the number of parts and $|\alpha|:=n$. Compositions of $n$ are in one-to-one correspondence with subsets of $\{1,2, \ldots, n-1\}$ via

$$
\alpha \mapsto I(\alpha):=\left\{a_{1}, a_{1}+a_{2}, \ldots, a_{1}+\cdots+a_{k-1}\right\} .
$$

For compositions $\alpha, \beta \vDash n$, we say that $\alpha$ refines $\beta$ if $I(\beta) \subseteq I(\alpha)$, and write $\beta \leqslant \alpha$.
The monomial quasi-symmetric function $M_{\alpha}$ indexed by $\alpha=\left(a_{1}, \ldots, a_{k}\right)$ is

$$
\begin{equation*}
M_{\alpha}:=\sum_{i_{1}<i_{2}<\cdots<i_{k}} x_{i_{1}}^{a_{1}} \cdots x_{i_{k}}^{a_{k}} . \tag{3.1}
\end{equation*}
$$

This is an element of the commutative algebra of formal power series in the variables $\left\{x_{i}\right\}_{i \geqslant 1}$. We agree that $M_{()}=1$, where () denotes the unique composition of 0 (with no parts). As $\alpha$ runs over all compositions of $n, n \geqslant 0$, the elements $M_{\alpha}$ span a subalgebra $\mathcal{Q} S y m$ of the algebra of formal

power series. It is the algebra of quasi-symmetric functions. It is in fact a graded subalgebra, the homogeneous component $\mathcal{Q S y m}_{n}$ of degree $n$ being spanned by $\left\{M_{\alpha}\right\}_{\alpha \models n}$. Thus, $\operatorname{dim} \mathcal{Q}^{\text {Sym }_{0}}=1$ and $\operatorname{dim} \mathcal{Q S y m}_{n}=2^{n-1}$ for $n \geqslant 1$.

There is a Hopf algebra structure on $\mathcal{Q} \operatorname{Sym}$ with comultiplication

$$
\begin{equation*}
\Delta\left(M_{\alpha}\right)=\sum_{\alpha=\beta \gamma} M_{\beta} \otimes M_{\gamma}, \tag{3.2}
\end{equation*}
$$

where $\beta \gamma$ is the concatenation of compositions $\beta$ and $\gamma$. The counit is projection onto the (onedimensional) component of degree 0; equivalently, it is the morphism of algebras that sends all variables $x_{i}$ to 0 . Thus, $\mathcal{Q}$ Sym is a graded connected bialgebra, and hence a graded Hopf algebra, by [MM65]. An explicit formula for the antipode is given below in Equation (4.7).

A second linear basis of $\mathcal{Q} \operatorname{Sym}_{n}$ (and thus of $\mathcal{Q S y m}$ ) is obtained by defining, for each $\alpha \vDash n$,

$$
\begin{equation*}
F_{\alpha}:=\sum_{\alpha \leqslant \beta} M_{\beta} . \tag{3.3}
\end{equation*}
$$

A partition of $n$ is a composition $\lambda=\left(l_{1}, \ldots, l_{k}\right)$ of $n$ such that $l_{1} \geqslant \cdots \geqslant l_{k}$. Given a composition $\alpha$, let $s(\alpha)$ be the partition obtained by rearranging the parts of $\alpha$ in decreasing order. The monomial symmetric functions are the elements

$$
\begin{equation*}
m_{\lambda}:=\sum_{s(\alpha)=\lambda} M_{\alpha} \tag{3.4}
\end{equation*}
$$

The subspace spanned by the elements $m_{\lambda}$, as $\lambda$ runs over all partitions, is a Hopf subalgebra of $\mathcal{Q}$ Sym. It is the Hopf algebra Sym of symmetric functions.

Let $\mathcal{N S y m}=\mathbb{k}\left\langle H_{1}, H_{2}, \ldots\right\rangle$ be the non-commutative algebra freely generated by infinitely many variables $\left\{H_{n}\right\}_{n \geqslant 1}$. Define

$$
\begin{equation*}
\Delta\left(H_{n}\right):=\sum_{i+j=n} H_{i} \otimes H_{j} \tag{3.5}
\end{equation*}
$$

where $H_{0}=1$. This turns $\mathcal{N}$ Sym into a graded connected Hopf algebra, where $\operatorname{deg}\left(H_{n}\right)=n$. A linear basis for the homogeneous component $\mathcal{N} S y m_{n}$ of degree $n$ is $\left\{H_{\alpha}\right\}_{\alpha \vDash n}$, where

$$
\begin{equation*}
H_{\left(a_{1}, a_{2}, \ldots, a_{k}\right)}:=H_{a_{1}} H_{a_{2}} \cdots H_{a_{k}} . \tag{3.6}
\end{equation*}
$$

The graded Hopf algebras $\mathcal{Q S y m}$ and $\mathcal{N}$ Sym are dual to each other, in the graded sense. The identification between $\mathcal{Q}$ Sym $_{n}$ and $\left(\mathcal{N S y m}_{n}\right)^{*}$ is

$$
\begin{equation*}
M_{\alpha} \leftrightarrow H_{\alpha}^{*} . \tag{3.7}
\end{equation*}
$$

The ideal $\mathcal{I}$ of $\mathcal{N}$ Sym generated by commutators is a Hopf ideal and the quotient $\mathcal{N} S y m / \mathcal{I}$ is Sym, the Hopf algebra of symmetric functions. The quotient map sends $H_{\alpha}$ to the complete homogeneous symmetric function $h_{s(\alpha)}$.

The Hopf algebra Sym is self-dual (in the graded sense), the identification being

$$
\begin{equation*}
m_{\lambda} \leftrightarrow h_{\lambda}^{*} . \tag{3.8}
\end{equation*}
$$

Therefore, the maps $\mathcal{N S y m} \rightarrow$ Sym and Sym $\hookrightarrow \mathcal{Q}$ Sym are dual to each other.

## 4. The terminal object in the category of combinatorial Hopf algebras

The results of this section do not require any assumptions on the base field $\mathbb{k}$.
We endow $\mathcal{Q S y m}$ with a canonical character. Let

$$
\zeta_{\mathcal{Q}}: \mathbb{k}\left[x_{1}, x_{2}, \ldots\right] \rightarrow \mathbb{k}
$$

be the morphism of algebras such that

$$
\zeta_{\mathcal{Q}}\left(x_{1}\right)=1 \text { and } \zeta_{\mathcal{Q}}\left(x_{i}\right)=0 \text { for all } i \neq 1
$$

The map $\zeta_{\mathcal{Q}}$ is actually defined on the algebra of power series of finite degree, and hence on $\mathcal{Q}$ Sym. Note also that all multiplicative functionals on power series which set one variable to 1 and the remaining variables to 0 agree when restricted to $\mathcal{Q} S y m$, by quasi-symmetry.

It follows from (3.1) and (3.3) that

$$
\zeta_{\mathcal{Q}}\left(M_{\alpha}\right)=\zeta_{\mathcal{Q}}\left(F_{\alpha}\right)= \begin{cases}1 & \text { if } \alpha=(n) \text { or }()  \tag{4.1}\\ 0 & \text { otherwise }\end{cases}
$$

By (3.7) we have

$$
\left.\zeta_{\mathcal{Q}}\right|_{(\mathcal{Q} \text { Sym })_{n}}=H_{n},
$$

as elements of $\left(\mathcal{Q S y m}_{n}\right)^{*}=\mathcal{N S y m}_{n}$.
The pair $\left(\mathcal{Q} \operatorname{Sym}, \zeta_{\mathcal{Q}}\right)$ is a terminal object both as a combinatorial coalgebra and as a combinatorial Hopf algebra.

Theorem 4.1. For any combinatorial coalgebra (Hopf algebra) $(\mathcal{H}, \zeta)$, there exists a unique morphism of combinatorial coalgebras (Hopf algebras)

$$
\Psi:(\mathcal{H}, \zeta) \rightarrow\left(\mathcal{Q} \text { Sym }, \zeta_{\mathcal{Q}}\right) .
$$

Moreover, $\Psi$ is explicitly given as follows. For $h \in \mathcal{H}_{n}$,

$$
\begin{equation*}
\Psi(h)=\sum_{\alpha \neq n} \zeta_{\alpha}(h) M_{\alpha} \tag{4.2}
\end{equation*}
$$

where, for $\alpha=\left(a_{1}, \ldots, a_{k}\right), \zeta_{\alpha}$ is the composite

$$
\mathcal{H} \xrightarrow{\Delta^{(k-1)}} \mathcal{H}^{\otimes k} \rightarrow \mathcal{H}_{a_{1}} \otimes \cdots \otimes \mathcal{H}_{a_{k}} \xrightarrow{\zeta^{\otimes k}} \mathbb{k}
$$

where the unlabeled map is the tensor product of the canonical projections onto the homogeneous components $\mathcal{H}_{a_{i}}$.

Proof. Consider the coalgebra case first. As recalled in § 3, the graded dual of the graded coalgebra $\mathcal{Q S y m}$ is the free algebra $\mathcal{N S y m}$, which has one generator $H_{n}$ of degree $n$ for every $n$. Given a graded coalgebra $\mathcal{H}$ and a linear functional $\zeta: \mathcal{H} \rightarrow \mathbb{k}$, let (as in $\S 1$ )

$$
\zeta_{n}:=\left.\zeta\right|_{\mathcal{H}_{n}}: \mathcal{H}_{n} \rightarrow \mathbb{k}
$$

Thus $\zeta_{n} \in\left(\mathcal{H}_{n}\right)^{*}$, and there is a unique morphism of graded algebras $\Phi: \mathcal{N} S y m \rightarrow \mathcal{H}^{*}$ such that $\Phi\left(H_{n}\right)=\zeta_{n}$.

Set $\Psi=\Phi^{*}: \mathcal{H} \rightarrow \mathcal{Q}$ Sym. Thus, $\Psi$ is a morphism of graded coalgebras and

$$
\left.\zeta_{\mathcal{Q}} \circ \Psi\right|_{\mathcal{H}_{n}}=\left.\left.\zeta_{\mathcal{Q}}\right|_{\mathcal{Q} S y m_{n}} \circ \Psi\right|_{\mathcal{H}_{n}}=\left.H_{n} \circ \Psi\right|_{\mathcal{H}_{n}}=\Phi\left(H_{n}\right)=\zeta_{n}=\zeta_{\mathcal{H}_{n}} .
$$

Thus, $\zeta_{\mathcal{Q}} \circ \Psi=\zeta$, proving that $\Psi: \mathcal{H} \rightarrow \mathcal{Q}$ Sym is a morphism of combinatorial coalgebras.
Let $\alpha=\left(a_{1}, \ldots, a_{k}\right)$. By construction, $\zeta_{\alpha}=\zeta_{a_{1}} \cdots \zeta_{a_{k}}$ (product in $\mathcal{H}^{*}$ ), and by (3.6), $H_{\alpha}=$ $H_{a_{1}} H_{a_{2}} \cdots H_{a_{k}}$ (product in $\mathcal{N S y m}$ ). Therefore, $\Phi\left(H_{\alpha}\right)=\zeta_{\alpha}$, and hence $\Psi$ is given by (4.2).

Uniqueness of $\Psi$ follows from uniqueness of $\Phi$, by duality.
Now suppose that $\mathcal{H}$ is a graded Hopf algebra and $\zeta$ is a morphism of algebras. It only remains to show that $\Psi$, as constructed above, is a morphism of algebras. Consider the following diagrams,

where $m$ denotes the multiplication map of $\mathcal{H}$ or of $\mathcal{Q}$ Sym.


These diagrams commute, by construction of $\Psi$ and since $\zeta$ and $\zeta_{\mathcal{Q}}$ are morphisms of algebras. Also, $\Psi \circ m$ and $m \circ \Psi^{\otimes 2}$ are morphisms of graded coalgebras. Hence, by the universal property of $\mathcal{Q}$ Sym as a combinatorial coalgebra applied to the functional $\zeta^{\otimes 2}$, we have $\Psi \circ m=m \circ \Psi^{\otimes 2}$. Thus, $\Psi$ is a morphism of algebras.

Remark 4.2. The pair $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$ is also the terminal object in the larger category of connected coalgebras (Hopf algebras) endowed with a linear (multiplicative) functional, without any assumptions on the existence of a grading. A direct proof of this statement (which cannot resort to the freeness of $\mathcal{N S y m}$ ) will be given in [Agu05]. For most applications of interest, however, the present result suffices.

The Hopf algebra of symmetric functions satisfies the same universal property but among cocommutative coalgebras. Let $\zeta_{S}: S y m \rightarrow \mathbb{k}$ denote the restriction of $\zeta_{\mathcal{Q}}: \mathcal{Q} S y m \rightarrow \mathbb{k}$. Thus,

$$
\zeta_{S}\left(m_{\lambda}\right)= \begin{cases}1 & \text { if } \lambda=(n) \text { or }() \\ 0 & \text { otherwise }\end{cases}
$$

Theorem 4.3. For any cocommutative combinatorial coalgebra (Hopf algebra) ( $\mathcal{H}, \zeta$ ), there exists a unique morphism of combinatorial coalgebras (Hopf algebras)

$$
\Psi:(\mathcal{H}, \zeta) \rightarrow\left(\text { Sym }, \zeta_{S}\right)
$$

Proof. The above argument can be repeated word by word, as the graded dual of Sym (Sym itself) is the free commutative algebra on the generators $\left\{h_{n}\right\}_{n \geqslant 1}$.

Example 4.4. Let $\mathcal{R}$ be Rota's Hopf algebra (Example 2.2). Theorem 4.1 yields a morphism of graded Hopf algebras $\Psi: \mathcal{R} \rightarrow \mathcal{Q}$ Sym. If $P$ is a graded poset of rank $n$ and $\alpha=\left(a_{1}, \ldots, a_{k}\right)$ is a composition of $n$, then $\zeta_{\alpha}(P)$ is the number of chains

$$
0_{P}=z_{0}<z_{1}<\cdots<z_{k}=1_{P}
$$

in $P$ such that $\operatorname{rk}\left[z_{i-1}, z_{i}\right]=a_{i}$ for every $i=1, \ldots, k$. Thus $\zeta_{\alpha}(P)=f_{\alpha}(P)$, the flag $f$-vector of $P$, and (4.2) becomes

$$
\Psi(P)=\sum_{\alpha \models n} f_{\alpha}(P) M_{\alpha}=\sum_{\substack{0_{P}=z_{0}<z_{1}<\cdots<z_{k}=1_{P} \\ i_{1}<\cdots<i_{k}}} x_{i_{1}}^{\mathrm{rk}\left[z_{0}, z_{1}\right]} \cdots x_{i_{k}}^{\mathrm{rk}\left[z_{k-1}, z_{k}\right]} .
$$

This morphism was introduced by Ehrenborg [Ehr96].
Example 4.5 (Chromatic Hopf algebra). Let $\mathcal{G}$ be the $\mathbb{k}$-vector space with basis the set of all isomorphism classes of finite (unoriented) graphs. Let $V(G)$ denote the set of vertices of a graph $G$. For $S \subseteq V(G)$, let $\left.G\right|_{S}$ denote the graph with set of vertices $S$ and with edges those edges of $G$ with both ends in $S$. The space $\mathcal{G}$ is a graded connected Hopf algebra with degree $|G|:=\# V(G)$ (number of vertices), product $G \cdot H:=G \sqcup H$ (disjoint union of graphs) and coproduct

$$
\Delta(G):=\left.\left.\sum_{S \subseteq V(G)} G\right|_{S} \otimes G\right|_{V(G) \backslash S} .
$$

Note that $\mathcal{G}$ is cocommutative. This Hopf algebra was considered by Schmitt [Sch94].

## Combinatorial Hopf algebras

A graph is discrete if it has no edges. Let $\zeta: \mathcal{G} \rightarrow \mathbb{k}$ be

$$
\zeta(G)= \begin{cases}1 & \text { if } G \text { is discrete } \\ 0 & \text { otherwise }\end{cases}
$$

Thus, $(\mathcal{G}, \zeta)$ is a cocommutative combinatorial Hopf algebra. Let $\Psi: \mathcal{G} \rightarrow$ Sym be the corresponding morphism of graded Hopf algebras given by Theorem 4.3. If $G$ is a graph with $n$ vertices and $\alpha=\left(a_{1}, \ldots, a_{k}\right)$ is a composition of $n$, then $\zeta_{\alpha}(G)$ is the number of ordered decompositions

$$
V(G)=S_{1} \sqcup \cdots \sqcup S_{k}
$$

such that $\left.G\right|_{S_{i}}$ is discrete and $\# S_{i}=a_{i}$ for every $i=1, \ldots, k$. A proper coloring of $G$ is a map $f: V(G) \rightarrow\{1,2, \ldots\}$ such that $f(v) \neq f(w)$ whenever there is an edge in $G$ joining $v$ and $w$. For each ordered decomposition as above and positive integers $i_{1}<\cdots<i_{k}$ there is a proper coloring $f$ given by $\left.f\right|_{S_{j}}=i_{j}$, and conversely. It follows from (3.1) and (4.2) that

$$
\Psi(G)=\sum_{f} \prod_{v \in V(G)} x_{f(v)},
$$

the sum over the set of proper colorings of $G$. The above function $\Psi(G)$ is Stanley's chromatic symmetric function [Sta95].

Example 4.6. In [BMSW00, BMSW02, BS99], morphisms of Hopf algebras were constructed from Pieri operations on posets. We explain this terminology and the connection to our constructions next.

Let $P$ be a fixed finite graded poset. Let $\mathcal{I}(P)$ denote the subspace of $\mathcal{R}$ linearly spanned by the (isomorphism classes of) intervals of $P$. Then $\mathcal{I}(P)$ is a graded subcoalgebra of $\mathcal{R}$ (in the terminology of Joni and Rota, this is the reduced incidence coalgebra of $P$ ). Let $\mathbb{k} P$ be the vector space with basis the underlying set of $P$. This carries a natural left graded comodule structure over $\mathcal{I}(P)$,

$$
\chi: \mathbb{k} P \rightarrow \mathcal{I}(P) \otimes \mathbb{k} P, \quad \chi(y)=\sum_{y \leqslant z}[y, z] \otimes z,
$$

where the degree of $z \in P$ is $\operatorname{rk}\left[0_{p}, z\right]$.
Now suppose that a linear functional $\zeta: \mathcal{I}(P) \rightarrow \mathbb{k}$ is given. By Theorem 4.1, there is a corresponding morphism of graded coalgebras $\Psi: \mathcal{I}(P) \rightarrow \mathcal{Q} S y m$. This allows us to view $\mathbb{k} P$ as a left graded comodule over $\mathcal{Q}$ Sym, via

$$
\mathbb{k} P \xrightarrow{\chi} \mathcal{I}(P) \otimes \mathbb{k} P \xrightarrow{\Psi \otimes \mathrm{id}} \mathcal{Q} S y m \otimes \mathbb{k} P, \quad y \mapsto \sum_{y \leqslant z} \Psi([y, z]) \otimes z .
$$

Dualizing, we obtain a right graded module structure on $\mathbb{k} P$ over $\mathcal{N}$ Sym, which is determined by

$$
y \cdot H_{n}=\sum_{\substack{y \leqslant z \\ \operatorname{rk}[y, z]=n}} \zeta([y, z]) \cdot z .
$$

In the terminology of [BMSW00], this right module structure constitutes a Pieri operation on $P$. Note that specifying such a structure is equivalent to giving the linear functional $\zeta$. The morphism of Hopf algebras constructed in [BMSW00] is $\Psi$. Thus, the construction of Hopf algebra morphisms from Pieri operations is another instance of the general construction of Theorem 4.1.

Many other examples of a combinatorial nature will be presented in [Agu05]. Additional applications of the universal property are discussed below (Examples 4.7-4.9).

Consider now the case when $\mathcal{H}=\mathcal{Q}$ Sym and $\zeta$ is an arbitrary character on $\mathcal{Q}$ Sym. Let $\alpha$ and $\beta$ be two compositions of $n$. It follows from (3.2) that

$$
\zeta_{\alpha}\left(M_{\beta}\right)= \begin{cases}\zeta\left(M_{\beta_{1}}\right) \cdots \zeta\left(M_{\beta_{h}}\right) & \text { if } \alpha \leqslant \beta \\ 0 & \text { otherwise }\end{cases}
$$

where, for $\alpha \leqslant \beta$, the non-empty compositions $\beta_{1}, \ldots, \beta_{h}$ are defined by $\beta=\beta_{1} \cdots \beta_{h}$ (concatenation of compositions) and $\alpha=\left(\left|\beta_{1}\right|, \ldots,\left|\beta_{h}\right|\right)$. Equation (4.2) becomes

$$
\begin{equation*}
\Psi\left(M_{\beta}\right)=\sum_{\beta=\beta_{1} \cdots \beta_{h}} \zeta\left(M_{\beta_{1}}\right) \cdots \zeta\left(M_{\beta_{h}}\right) M_{\left(\left|\beta_{1}\right|, \ldots,\left|\beta_{h}\right|\right)} \tag{4.3}
\end{equation*}
$$

In particular, $\Psi$ is triangular with respect to refinement of compositions, and $\Psi$ is an isomorphism if and only if $\zeta\left(M_{(n)}\right) \neq 0$ for every $n$.

Example 4.7. Let $m \in \mathbb{Z}$ be an integer and $\Psi_{m}: \mathcal{Q S y m} \rightarrow \mathcal{Q}$ Sym be the unique morphism of Hopf algebras such that $\zeta_{\mathcal{Q}} \circ \Psi_{m}=\zeta_{\mathcal{Q}}^{m}$, the $m$ th convolution power of $\zeta_{\mathcal{Q}}$. It follows from (3.2) that for any composition $\beta$ and non-negative integer $m$,

$$
\begin{equation*}
\zeta_{\mathcal{Q}}^{m}\left(M_{\beta}\right)=\binom{m}{k(\beta)} \tag{4.4}
\end{equation*}
$$

(For general reasons, this formula remains valid for negative integers $m$ as well.)
Then, by (4.3),

$$
\begin{equation*}
\Psi_{m}\left(M_{\beta}\right)=\sum_{\beta=\beta_{1} \cdots \beta_{h}}\binom{m}{k\left(\beta_{1}\right)} \cdots\binom{m}{k\left(\beta_{h}\right)} M_{\left(\left|\beta_{1}\right|, \ldots,\left|\beta_{h}\right|\right)} . \tag{4.5}
\end{equation*}
$$

In particular, $\Psi_{1}=\mathrm{id}$ (as had to be the case by uniqueness) and

$$
\Psi_{-1}\left(M_{\beta}\right)=(-1)^{k(\beta)} \sum_{\alpha \leqslant \beta} M_{\alpha} .
$$

Example 4.8. Recall that the coopposite coalgebra $C^{\text {cop }}$ of a coalgebra $C$ is obtained by reversing the order of the tensor factors in the coproduct of $C$. Let us apply the universal property to $(\mathcal{H}, \zeta)=\left(\mathcal{Q}\right.$ Sym $\left.^{\mathrm{cop}}, \zeta_{\mathcal{Q}}^{-1}\right)$. The resulting morphism of Hopf algebras $\mathcal{Q}$ Sym $^{\mathrm{cop}} \rightarrow \mathcal{Q}$ Sym is the antipode $S$ of $\mathcal{Q}$ Sym, since $S: \mathcal{Q} S y m \rightarrow \mathcal{Q}$ Sym is an antimorphism of coalgebras and $\zeta_{\mathcal{Q}} \circ S=\zeta_{\mathcal{Q}}^{-1}$ (see § 1). Theorem 4.1 will thus furnish an explicit formula for the antipode of $\mathcal{Q S y m}$. From (4.4), and since $\binom{-1}{k}=(-1)^{k}$, we get

$$
\begin{equation*}
\zeta_{\mathcal{Q}}^{-1}\left(M_{\beta}\right)=(-1)^{k(\beta)} . \tag{4.6}
\end{equation*}
$$

(This may also be obtained directly from the recursion $\zeta_{\mathcal{Q}}^{-1} \zeta_{\mathcal{Q}}=\epsilon$.)
Then, since $\Delta^{\operatorname{cop}}\left(M_{\left(a_{1}, \ldots, a_{k}\right)}\right)=\sum_{i=0}^{k} M_{\left(a_{i+1}, \ldots, a_{1}\right)} \otimes M_{\left(a_{1}, \ldots, a_{i}\right)}$, Equation (4.2) yields

$$
\begin{equation*}
S\left(M_{\beta}\right)=(-1)^{k(\beta)} \sum_{\alpha \leqslant \widetilde{\beta}} M_{\alpha} \tag{4.7}
\end{equation*}
$$

where if $\beta=\left(b_{1}, b_{2}, \ldots, b_{k}\right)$ then $\widetilde{\beta}=\left(b_{k}, \ldots, b_{2}, b_{1}\right)$. This formula appears in [Ehr96] and [Ma194].
Example 4.9. Consider the odd character $\nu_{\mathcal{Q}}=\bar{\zeta}_{\mathcal{Q}}^{-1} \zeta_{\mathcal{Q}}$ (Example 1.3). It follows from (4.6) that $\bar{\zeta}_{\mathcal{Q}}^{-1}\left(M_{\beta}\right)=(-1)^{|\beta|+k(\beta)}$. Let $\beta=\left(b_{1}, \ldots, b_{k}\right)$. In

$$
\nu_{\mathcal{Q}}\left(M_{\beta}\right)=\sum_{i=0}^{k} \bar{\zeta}_{\mathcal{Q}}^{-1}\left(M_{\left(b_{1}, \ldots, b_{i}\right)}\right) \zeta_{\mathcal{Q}}\left(M_{\left(b_{i+1}, \ldots, b_{k}\right)}\right)
$$

only the terms corresponding to $i=k-1$ and $i=k$ are non-zero. These cancel each other if $b_{k}$ is even and are equal to $(-1)^{|\beta|+k(\beta)}$ if $b_{k}$ is odd. Thus,

$$
\nu_{\mathcal{Q}}\left(M_{\beta}\right)= \begin{cases}1 & \text { if } \beta=(),  \tag{4.8}\\ 2 \times(-1)^{|\beta|+k(\beta)} & \text { if the last part of } \beta \text { is odd, } \\ 0 & \text { otherwise. }\end{cases}
$$

Let $\Theta: \mathcal{Q}$ Sym $\rightarrow \mathcal{Q}$ Sym be the unique morphism of Hopf algebras such that $\zeta_{\mathcal{Q}} \circ \Theta=\nu_{\mathcal{Q}}$. By (4.3),

$$
\Theta\left(M_{\beta}\right)=\sum_{\beta=\beta_{1} \cdots \beta_{h}} \nu_{\mathcal{Q}}\left(M_{\beta_{1}}\right) \cdots \nu_{\mathcal{Q}}\left(M_{\beta_{h}}\right) M_{\left(\left|\beta_{1}\right|, \ldots,\left|\beta_{h}\right|\right)} .
$$

Let $\alpha=\left(\left|\beta_{1}\right|, \ldots,\left|\beta_{h}\right|\right)$. For $M_{\alpha}$ to appear in the above sum, the last part of each $\beta_{i}$ must be odd. In this case, $M_{\alpha}$ appears with coefficient

$$
2^{\sum_{i=1}^{h} 1} \times(-1)^{\sum_{i=1}^{h}\left|\beta_{i}\right|+k\left(\beta_{i}\right)}=2^{k(\alpha)} \times(-1)^{|\beta|+k(\beta)} .
$$

Thus,

$$
\Theta\left(M_{\beta}\right)=(-1)^{|\beta|+k(\beta)} \sum_{\alpha} 2^{k(\alpha)} M_{\alpha}
$$

the sum over those $\alpha \leqslant \beta$ obtained by adding the entries within consecutive segments $\beta_{1}, \ldots, \beta_{h}$ of $\beta$ with the property that the last part of each $\beta_{i}$ is odd. This set of compositions is empty if the last part of $\beta$ is even. Otherwise, it is a lower interval whose maximum element is the composition obtained by adding the entries within each maximal segment of $\beta$ of the form (even, even, ...,odd). Let $\operatorname{odd}(\beta)$ denote this element. For instance, odd $(1,2,2,1,3,2,3)=(1,5,3,5)$. It follows that

$$
\Theta\left(M_{\beta}\right)=\left\{\begin{array}{lll}
1 & \text { if } \beta=()  \tag{4.9}\\
(-1)^{|\beta|+k(\beta)} \sum_{\alpha \leqslant \operatorname{odd}(\beta)} 2^{k(\alpha)} M_{\alpha} & \text { if the last part of } \beta \text { is odd, } \\
0 & \text { otherwise }
\end{array}\right.
$$

This shows that $\Theta$ is the morphism of Hopf algebras introduced by Stembridge [Ste97, Theorem 3.1]. Up to a sign, the elements $\Theta\left(M_{\beta}\right)$ are the shifted quasi-symmetric functions of [BH95, eq. (3.2)]. The map $\Theta$ was originally defined in the $F$-basis of $\mathcal{Q}$ Sym. From here, Hsiao derived an expression in the $M$-basis [Hsi02, Theorem 2.4], which agrees with (4.9). The original expression may also be easily obtained through the universal property of $\mathcal{Q S y m}$, starting from the fact that

$$
\nu_{\mathcal{Q}}\left(F_{\alpha}\right)= \begin{cases}1 & \text { if } \alpha=() \\ 2 & \text { if } \alpha=(1,1, \ldots, 1, k) \\ 0 & \text { otherwise }\end{cases}
$$

Other characters on $\mathcal{Q}$ Sym and the corresponding morphisms are discussed in § 6 .

## 5. Even and odd subalgebras of a combinatorial Hopf algebra

Let $\mathcal{H}$ be a graded connected Hopf algebra. Given a linear functional $\varphi: \mathcal{H} \rightarrow \mathbb{k}$, we let $\varphi_{n}:=\left.\varphi\right|_{\mathcal{H}_{n}}$. This is an element of degree $n$ of the graded dual $\mathcal{H}^{*}$.

Definition 5.1. Given characters $\varphi, \psi: \mathcal{H} \rightarrow \mathbb{k}$, we let $S(\varphi, \psi)$ denote the largest graded subcoalgebra of $\mathcal{H}$ such that

$$
\forall h \in S(\varphi, \psi), \quad \varphi(h)=\psi(h),
$$

and we let $I(\varphi, \psi)$ denote the ideal of $\mathcal{H}^{*}$ generated by

$$
\varphi_{n}-\psi_{n}, \quad n \geqslant 0
$$

Remark 5.2. By definition, $S(\varphi, \psi)$ is the largest graded subcoalgebra contained in $\operatorname{ker}(\varphi-\psi)$ (a subspace of codimension $\leqslant 1)$. It is easy to see that $S(\varphi, \psi)$ may also be defined as the largest subcoalgebra (graded or not) contained in the graded subspace $\bigoplus_{n \geqslant 0} \operatorname{ker}\left(\varphi_{n}-\psi_{n}\right)$ (this is the approach taken in [Agu02]). We will not make use of this fact.

The basic properties of these objects follow.

## Theorem 5.3.

(a) $S(\varphi, \psi)=\{h \in \mathcal{H} \mid f(h)=0 \forall f \in I(\varphi, \psi)\}$.
(b) $I(\varphi, \psi)$ is a graded Hopf ideal of $\mathcal{H}^{*}$.
(c) $S(\varphi, \psi)$ is a graded Hopf subalgebra of $\mathcal{H}$.
(d) A homogeneous element $h \in \mathcal{H}$ belongs to $S(\varphi, \psi)$ if and only if

$$
\begin{equation*}
(\mathrm{id} \otimes(\varphi-\psi) \otimes \mathrm{id}) \circ \Delta^{(2)}(h)=0 \tag{5.1}
\end{equation*}
$$

Proof. Write $I(\varphi, \psi)^{\perp}:=\{h \in \mathcal{H} \mid f(h)=0 \forall f \in I(\varphi, \psi)\}$. Since $I(\varphi, \psi)$ is generated by homogeneous elements, it is a graded ideal of $\mathcal{H}^{*}$. Hence $I(\varphi, \psi)^{\perp}$ is a graded subcoalgebra of $\mathcal{H}$.

If $h \in I(\varphi, \psi)^{\perp}$ then

$$
\varphi(h)=\sum_{n} \varphi_{n}(h)=\sum_{n} \psi_{n}(h)=\psi(h),
$$

since $\varphi_{n}-\psi_{n} \in I(\varphi, \psi)$. Therefore, $I(\varphi, \psi)^{\perp} \subseteq S(\varphi, \psi)$.
Let $C$ be a graded subcoalgebra of $\mathcal{H}$ such that $\varphi(h)=\psi(h)$ for all $h \in C$. Let $h \in C$. Write $h=\sum_{n} h_{n}$. Since $C$ is graded, each $h_{n} \in C$. Hence,

$$
\left(\varphi_{n}-\psi_{n}\right)(h)=\left(\varphi_{n}-\psi_{n}\right)\left(h_{n}\right)=(\varphi-\psi)\left(h_{n}\right)=0
$$

Thus, $\left(\varphi_{n}-\psi_{n}\right)(C)=0$ for all $n \geqslant 0$. Since $C$ is a subcoalgebra and $I(\varphi, \psi)$ is the ideal generated by $\varphi_{n}-\psi_{n}, n \geqslant 0$, it follows that $f(C)=0$ for all $f \in I(\varphi, \psi)$. Thus, $C \subseteq I(\varphi, \psi)^{\perp}$ and hence $S(\varphi, \psi) \subseteq I(\varphi, \psi)^{\perp}$. The proof of part (a) is complete.

If $C$ and $D$ are graded subcoalgebras of $\mathcal{H}$, then so is their product $C \cdot D$. Also, since $\varphi$ and $\psi$ are characters we have

$$
(\varphi-\psi)(x y)=(\varphi-\psi)(x) \varphi(y)+\psi(x)(\varphi-\psi)(y)
$$

Hence, if $(\varphi-\psi)(C)=(\varphi-\psi)(D)=0$, then $(\varphi-\psi)(C \cdot D)=0$. It follows that $S(\varphi, \psi) \cdot S(\varphi, \psi) \subseteq$ $S(\varphi, \psi)$. Also, $\mathcal{H}_{0}=\mathbb{k} \cdot 1$ is a graded subcoalgebra of $\mathcal{H}$ and $\varphi(1)=1=\psi(1)$, so it is contained in $S(\varphi, \psi)$. Thus, $S(\varphi, \psi)$ is a subalgebra of $\mathcal{H}$ and by part (a) $I(\varphi, \psi)$ is a coideal of $\mathcal{H}^{*}$. This completes the proofs of parts (b) and (c).

Let $h$ be a homogeneous element satisfying (5.1). Then

$$
\sum_{n \geqslant 0}\left(\mathrm{id} \otimes\left(\varphi_{n}-\psi_{n}\right) \otimes \mathrm{id}\right) \circ \Delta^{(2)}(h)=0 .
$$

Each term in this sum is homogeneous and their degrees are distinct. Therefore, for each $n \geqslant 0$,

$$
\left(\mathrm{id} \otimes\left(\varphi_{n}-\psi_{n}\right) \otimes \mathrm{id}\right) \circ \Delta^{(2)}(h)=0
$$

Let $\lambda, \rho$ be arbitrary elements of $\mathcal{H}^{*}$. We deduce that, for each $n \geqslant 0$,

$$
\left(\lambda\left(\varphi_{n}-\psi_{n}\right) \rho\right)(h)=\left(\lambda \otimes\left(\varphi_{n}-\psi_{n}\right) \otimes \rho\right) \circ \Delta^{(2)}(h)=0 .
$$

It follows that for any $f \in I(\varphi, \psi), f(h)=0$. Thus, by part (a), $h \in S(\varphi, \psi)$.

## Combinatorial Hopf algebras

Conversely, let $C$ be a graded subcoalgebra of $\mathcal{H}$ such that $(\varphi-\psi)(C)=0$. Then

$$
(\mathrm{id} \otimes(\varphi-\psi) \otimes \mathrm{id}) \circ \Delta^{(2)}(C) \subseteq C \otimes(\varphi-\psi)(C) \otimes C=0
$$

Thus, every homogeneous element of $C$ satisfies (5.1). This applies in particular to $C=S(\varphi, \psi)$, which completes the proof of part (d).

Corollary 5.4. There is an isomorphism of graded Hopf algebras

$$
S(\varphi, \psi)^{*} \cong \mathcal{H}^{*} / I(\varphi, \psi) .
$$

Proof. This follows at once from Theorem 5.3.
Proposition 5.5. Let $\varphi, \varphi^{\prime}, \psi, \psi^{\prime}$ be characters on $\mathcal{H}$. Suppose that either

$$
\psi^{-1} \varphi=\left(\psi^{\prime}\right)^{-1} \varphi^{\prime} \quad \text { or } \quad \varphi \psi^{-1}=\varphi^{\prime}\left(\psi^{\prime}\right)^{-1} .
$$

Then

$$
S(\varphi, \psi)=S\left(\varphi^{\prime}, \psi^{\prime}\right) \quad \text { and } \quad I(\varphi, \psi)=I\left(\varphi^{\prime}, \psi^{\prime}\right) .
$$

Proof. Suppose $\psi^{-1} \varphi=\left(\psi^{\prime}\right)^{-1} \varphi^{\prime}$. Then

$$
\psi^{-1}(\varphi-\psi)=\psi^{-1} \varphi-\epsilon=\left(\psi^{\prime}\right)^{-1} \varphi^{\prime}-\epsilon=\left(\psi^{\prime}\right)^{-1}\left(\varphi^{\prime}-\psi^{\prime}\right) .
$$

Passing to homogeneous components we see that $\varphi_{n}-\psi_{n}$ belongs to the (left) ideal generated by $\varphi_{n}^{\prime}-\psi_{n}^{\prime}, n \geqslant 0$. Thus $I(\varphi, \psi)=I\left(\varphi^{\prime}, \psi^{\prime}\right)$ and, by Theorem 5.3, $S(\varphi, \psi)=S\left(\varphi^{\prime}, \psi^{\prime}\right)$. The other case follows similarly.

Note also that $S(\varphi, \psi)=S(\psi, \varphi)$ and $I(\varphi, \psi)=I(\psi, \varphi)$ (symmetry).
Proposition 5.6. Let $\alpha: \mathcal{H}^{\prime} \rightarrow \mathcal{H}$ be a morphism of graded connected Hopf algebras. Let $\varphi, \psi$ be characters of $\mathcal{H}$ and $\varphi^{\prime}:=\varphi \circ \alpha, \psi^{\prime}:=\psi \circ \alpha$. Then
(a) $\alpha\left(S\left(\varphi^{\prime}, \psi^{\prime}\right)\right) \subseteq S(\varphi, \psi)$;
(b) $I\left(\varphi^{\prime}, \psi^{\prime}\right)$ is the ideal of $\left(\mathcal{H}^{\prime}\right)^{*}$ generated by $\alpha^{*}(I(\varphi, \psi))$.

Moreover, if $\alpha$ is injective then

$$
S\left(\varphi^{\prime}, \psi^{\prime}\right)=\alpha^{-1}(S(\varphi, \psi)) \quad \text { and } \quad I\left(\varphi^{\prime}, \psi^{\prime}\right)=\alpha^{*}(I(\varphi, \psi)) .
$$

Proof. By hypothesis, $\alpha\left(\operatorname{ker}\left(\varphi^{\prime}-\psi^{\prime}\right)\right) \subseteq \operatorname{ker}(\varphi-\psi)$. Since the image under $\alpha$ of a graded subcoalgebra is another graded subcoalgebra, $\alpha\left(S\left(\varphi^{\prime}, \psi^{\prime}\right)\right)$ is a graded subcoalgebra contained in $\operatorname{ker}(\varphi-\psi)$, and hence also in $S(\varphi, \psi)$. This proves part (a).

Since $\alpha^{*}\left(\varphi_{n}-\psi_{n}\right)=\varphi_{n}^{\prime}-\psi_{n}^{\prime}, \alpha^{*}$ carries the generators of the ideal $I(\varphi, \psi)$ of $\mathcal{H}^{*}$ to the generators of the ideal $I\left(\varphi^{\prime}, \psi^{\prime}\right)$ of $\left(\mathcal{H}^{\prime}\right)^{*}$. This implies part (b).

If $\alpha$ is injective then the preimage under $\alpha$ of a subcoalgebra of $\mathcal{H}$ is a subcoalgebra of $\mathcal{H}^{\prime}$. Therefore, $\alpha^{-1}(S(\varphi, \psi))$ is a graded subcoalgebra of $\mathcal{H}^{\prime}$ contained in $\alpha^{-1}(\operatorname{ker}(\varphi-\psi))=\operatorname{ker}\left(\varphi^{\prime}-\psi^{\prime}\right)$, and hence also in $S\left(\varphi^{\prime}, \psi^{\prime}\right)$.

Finally, in this situation $\alpha^{*}$ is surjective, so the image of an ideal of $\mathcal{H}^{*}$ under $\alpha^{*}$ is an ideal of $\left(\mathcal{H}^{\prime}\right)^{*}$. Hence, by part (b), $I\left(\varphi^{\prime}, \psi^{\prime}\right)=\alpha^{*}(I(\varphi, \psi))$.

We now specialize these constructions.
Definition 5.7. Let $(\mathcal{H}, \zeta)$ be a combinatorial Hopf algebra. The even and odd subalgebras of $\mathcal{H}$ are respectively

$$
S_{+}(\mathcal{H}, \zeta):=S(\bar{\zeta}, \zeta) \quad \text { and } \quad S_{-}(\mathcal{H}, \zeta):=S\left(\bar{\zeta}, \zeta^{-1}\right)
$$

The even and odd ideals of $\mathcal{H}^{*}$ are respectively

$$
I_{+}(\mathcal{H}, \zeta):=I(\bar{\zeta}, \zeta) \quad \text { and } \quad I_{-}(\mathcal{H}, \zeta):=I\left(\bar{\zeta}, \zeta^{-1}\right)
$$

Specializing the previous results we obtain the basic properties of even and odd subalgebras and ideals.

Proposition 5.8. Let $(\mathcal{H}, \zeta)$ be a combinatorial Hopf algebra.
(a) $S_{+}(\mathcal{H}, \zeta)$ and $S_{-}(\mathcal{H}, \zeta)$ are graded Hopf subalgebras of $\mathcal{H}, I_{+}(\mathcal{H}, \zeta)$ and $I_{-}(\mathcal{H}, \zeta)$ are graded Hopf ideals of $\mathcal{H}^{*}$, and there are isomorphisms of graded Hopf algebras

$$
S_{ \pm}(\mathcal{H}, \zeta)^{*} \cong \mathcal{H}^{*} / I_{ \pm}(\mathcal{H}, \zeta) .
$$

(b) $S_{+}(\mathcal{H}, \zeta)$ and $S_{-}(\mathcal{H}, \zeta)$ are the largest subcoalgebras with the properties that

$$
\left.\zeta(h)=(-1)^{n} \zeta(h) \text { (respectively } \zeta^{-1}(h)=(-1)^{n} \zeta(h)\right)
$$

for every $h \in S_{+}(\mathcal{H}, \zeta)$ (respectively $\left.S_{-}(\mathcal{H}, \zeta)\right)$ of degree $n$.
(c) $\zeta$ is even if and only if $S_{+}(\mathcal{H}, \zeta)=\mathcal{H}$ and $\zeta$ is odd if and only if $S_{-}(\mathcal{H}, \zeta)=\mathcal{H}$.
(d) Let $\nu=\bar{\zeta}^{-1} \zeta$ and $\chi=\bar{\zeta} \zeta$ be the canonical characters of Example 1.3. We have

$$
S_{+}(\mathcal{H}, \zeta)=S(\nu, \epsilon) \quad \text { and } \quad S_{-}(\mathcal{H}, \zeta)=S(\chi, \epsilon)
$$

and similarly for $I_{ \pm}$.
(e) Let $\alpha:\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right) \rightarrow(\mathcal{H}, \zeta)$ be a morphism of combinatorial Hopf algebras. Then

$$
\alpha\left(S_{ \pm}\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right)\right) \subseteq S_{ \pm}(\mathcal{H}, \zeta)
$$

and $I_{ \pm}\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right)$ is the ideal of $\left(\mathcal{H}^{\prime}\right)^{*}$ generated by $\alpha^{*}\left(I_{ \pm}(\mathcal{H}, \zeta)\right)$.
(f) If in addition $\alpha$ is injective then

$$
S_{ \pm}\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right)=\alpha^{-1}\left(S_{ \pm}(\mathcal{H}, \zeta)\right) \quad \text { and } \quad I_{ \pm}\left(\mathcal{H}^{\prime}, \zeta^{\prime}\right)=\alpha^{*}\left(I_{ \pm}(\mathcal{H}, \zeta)\right) .
$$

Proof. These assertions are special cases of Theorem 5.3, Corollary 5.4, and Propositions 5.5 and 5.6.

Even and odd characters of $\mathcal{H}$ are related to the even and odd subalgebras of the dual $\mathcal{H}^{*}$, as we now explain. Let $\mathcal{H}$ be a graded connected Hopf algebra, $\zeta: \mathcal{H} \rightarrow \mathbb{k}$ a character on $\mathcal{H}$ and $\eta: \mathcal{H}^{*} \rightarrow \mathbb{k}$ a character on its dual. We do not assume any compatibility between $\zeta$ and $\eta$. Note that each component $\zeta_{n}=\left.\zeta\right|_{\mathcal{H}_{n}}$ is a homogeneous element of $\mathcal{H}^{*}$.
Proposition 5.9. In the above situation, if $\zeta$ is even (respectively, odd) then each component $\zeta_{n}$ belongs to $S_{+}\left(\mathcal{H}^{*}, \eta\right)$ (respectively, $S_{-}\left(\mathcal{H}^{*}, \eta\right)$ ).
Proof. Observe first that

$$
\bar{\eta}\left(\zeta_{n}\right)=(-1)^{n} \eta\left(\zeta_{n}\right)=\eta\left(\bar{\zeta}_{n}\right)
$$

and

$$
\eta^{-1}\left(\zeta_{n}\right)=\left(\eta \circ S_{\mathcal{H}^{*}}\right)\left(\zeta_{n}\right)=\eta\left(\zeta_{n} \circ S_{\mathcal{H}}\right)=\eta\left(\zeta_{n}^{-1}\right) .
$$

Recall that characters of $\mathcal{H}$ are group-like elements of $\mathcal{H}^{\circ}$. Hence,

$$
\Delta_{\mathcal{H}^{*}}\left(\zeta_{n}\right)=\sum_{i+j=n} \zeta_{i} \otimes \zeta_{j} .
$$

Suppose now that $\zeta$ is odd. We have

$$
\begin{aligned}
\left(\mathrm{id} \otimes\left(\bar{\eta}-\eta^{-1}\right) \otimes \mathrm{id}\right) \circ \Delta_{\mathcal{H}^{*}}^{(2)}\left(\zeta_{n}\right) & =\sum_{i+j+h=n} \zeta_{i} \otimes\left(\bar{\eta}-\eta^{-1}\right)\left(\zeta_{j}\right) \otimes \zeta_{h} \\
& =\sum_{i+j+h=n} \zeta_{i} \otimes\left(\eta\left(\bar{\zeta}_{j}\right)-\eta\left(\zeta_{j}^{-1}\right)\right) \otimes \zeta_{h}=0,
\end{aligned}
$$

since $\bar{\zeta}_{j}=\zeta_{j}^{-1}$ for every $j$. Thus, by part (d) of Theorem 5.3, $\zeta_{n} \in S_{-}\left(\mathcal{H}^{*}, \eta\right)$. The even case is similar.

## Combinatorial Hopf algebras

## Generalized Dehn-Sommerville relations

Let $(\mathcal{H}, \zeta)$ be a combinatorial Hopf algebra. Consider its odd subalgebra

$$
S_{-}(\mathcal{H}, \zeta)=S\left(\bar{\zeta}, \zeta^{-1}\right)=S(\chi, \epsilon) .
$$

Let $h \in \mathcal{H}$ be a homogeneous element. According to (5.1), the following conditions are equivalent:

$$
\begin{gather*}
h \in S_{-}(\mathcal{H}, \zeta) \\
\left(\mathrm{id} \otimes\left(\bar{\zeta}-\zeta^{-1}\right) \otimes \mathrm{id}\right) \circ \Delta^{(2)}(h)=0  \tag{5.2}\\
(\mathrm{id} \otimes(\chi-\epsilon) \otimes \mathrm{id}) \circ \Delta^{(2)}(h)=0 \tag{5.3}
\end{gather*}
$$

We refer to either set of equations (5.2) or (5.3) as the generalized Dehn-Sommerville relations for the combinatorial Hopf algebra $(\mathcal{H}, \zeta)$. As they both define the same subalgebra of $\mathcal{H}$, they have the same solutions.

Example 5.10. We describe the generalized Dehn-Sommerville relations for the combinatorial Hopf algebra $\left(\mathcal{Q}\right.$ Sym, $\left.\zeta_{\mathcal{Q}}\right)$. First, from (4.6) we get

$$
\left(\bar{\zeta}_{\mathcal{Q}}-\zeta_{\mathcal{Q}}^{-1}\right)\left(M_{\beta}\right)= \begin{cases}0 & \text { if } \beta=()  \tag{5.4}\\ (-1)^{n}+1 & \text { if } \beta=(n) \\ -(-1)^{k(\beta)} & \text { otherwise }\end{cases}
$$

Given an element $h=\sum_{\gamma \vDash n} f_{\gamma}(h) M_{\gamma} \in \mathcal{Q}$ Sym $_{n}$, a composition $\alpha=\left(a_{1}, \ldots, a_{k}\right) \vDash n$, and a number $i \in\{1, \ldots, k\}$, set

$$
E_{\alpha, i}(h):=(-1)^{a_{i}} f_{\alpha}(h)-\sum_{\beta \neq a_{i}}(-1)^{k(\beta)} f_{\alpha \circ_{i} \beta}(h) .
$$

Here, $\alpha \circ_{i} \beta$ denotes the composition of $n$ obtained by replacing the $i$ th part of $\alpha$ by the parts of $\beta$ : if $\beta=\left(b_{1}, \ldots, b_{h}\right)$,

$$
\alpha \circ_{i} \beta:=\left(a_{1}, \ldots, a_{i-1}, b_{1}, \ldots, b_{h}, a_{i+1}, \ldots, a_{k}\right) .
$$

Also, write

$$
\alpha_{i}:=\left(a_{1}, \ldots, a_{i-1}\right) \quad \text { and } \quad \alpha^{i}:=\left(a_{i+1}, \ldots, a_{k}\right) .
$$

It follows from (5.4) and (3.2) that

$$
\left(\mathrm{id} \otimes\left(\bar{\zeta}_{\mathcal{Q}}-\zeta_{\mathcal{Q}}^{-1}\right) \otimes \mathrm{id}\right) \circ \Delta^{(2)}(h)=\sum_{\alpha \neq n} \sum_{i=1}^{k(\alpha)} E_{\alpha, i}(h) \cdot M_{\alpha_{i}} \otimes M_{\alpha^{i}}
$$

Since this is a sum of linearly independent tensors, the generalized Dehn-Sommerville relations (5.2) for the element $h$ are

$$
E_{\alpha, i}(h)=0 \quad \text { for each } \alpha \vDash n \text { and } i \in\{1, \ldots, k(\alpha)\},
$$

or explicitly

$$
(-1)^{a_{i}} f_{\alpha}(h)=\sum_{\beta \neq a_{i}}(-1)^{k(\beta)} f_{\alpha \circ_{i} \beta}(h) .
$$

Thus, an element $h \in \mathcal{Q}$ Sym of degree $n$ belongs to $S_{-}\left(\mathcal{Q} S y m, \zeta_{\mathcal{Q}}\right)$ if and only if these relations are satisfied. This form of the generalized Dehn-Sommerville relations was introduced in [Agu02, § 7].

Now consider (5.3), the second form of the generalized Dehn-Sommerville relations. From (4.1) we get

$$
\left(\chi_{\mathcal{Q}}-\epsilon_{\mathcal{Q}}\right)\left(M_{\beta}\right)= \begin{cases}1+(-1)^{n} & \text { if } \beta=(n)  \tag{5.5}\\ (-1)^{i} & \text { if } \beta=(i, n-i) \\ 0 & \text { otherwise }\end{cases}
$$

Therefore,

$$
\left(\operatorname{id} \otimes\left(\chi_{\mathcal{Q}}-\epsilon_{\mathcal{Q}}\right) \otimes \mathrm{id}\right) \circ \Delta^{(2)}(h)=\sum_{\alpha \models n} \sum_{i=1}^{k(\alpha)} B_{\alpha, i}(h) \cdot M_{\alpha_{i}} \otimes M_{\alpha^{i}},
$$

with

$$
B_{\alpha, i}(h)=\sum_{j=0}^{a_{i}}(-1)^{j} f_{\left(a_{1}, \ldots, a_{i-1}, j, a_{i}-j, a_{i+1}, \ldots, a_{k}\right)}(h),
$$

where it is understood that zero parts are omitted. Thus, relations (5.3) for the element $h$ are

$$
\sum_{j=0}^{a_{i}}(-1)^{j} f_{\left(a_{1}, \ldots, a_{i-1}, j, a_{i}-j, a_{i+1}, \ldots, a_{k}\right)}(h)=0 \quad \text { for each }\left(a_{1}, \ldots, a_{k}\right) \vDash n, i \in\{1, \ldots, k\} .
$$

These are precisely the original generalized Dehn-Sommerville relations as introduced by Bayer and Billera [BB85, Theorem 2.1].

Consider the combinatorial Hopf algebra $(\mathcal{R}, \zeta)$ of Example 2.2. Let $\mathcal{E}$ be the subspace of $\mathcal{R}$ spanned by all Eulerian posets. Recall that a finite graded poset $P$ is Eulerian if its Möbius function satisfies $\mu([x, y])=(-1)^{\mathrm{rk}[x, y]}$ for every $x<y$ in $P$. In particular, intervals of an Eulerian poset and Cartesian products of Eulerian posets are again Eulerian, so $\mathcal{E}$ is a Hopf subalgebra of $\mathcal{R}$.

According to Example 2.2, for any $P \in \mathcal{E}$ we have

$$
\zeta^{-1}(P)=\bar{\zeta}(P)
$$

Therefore, $\mathcal{E}$ must be contained in the odd subalgebra of $\mathcal{R}$ :

$$
\mathcal{E} \subseteq S_{-}(\mathcal{R}, \zeta)
$$

Let $\Psi:(\mathcal{R}, \zeta) \rightarrow\left(\mathcal{Q} S y m, \zeta_{\mathcal{Q}}\right)$ be the unique morphism of combinatorial Hopf algebras, as in Example 4.4:

$$
\Psi(P)=\sum_{\alpha \neq n} f_{\alpha}(P) M_{\alpha},
$$

where $f_{\alpha}(P)$ is the flag vector of $P$. By part (e) of Proposition 5.8,

$$
\Psi(\mathcal{E}) \subseteq \Psi\left(S_{-}(\mathcal{R}, \zeta)\right) \subseteq S_{-}\left(\mathcal{Q} \text { Sym }, \zeta_{\mathcal{Q}}\right)
$$

We thus recover the important result of Bayer and Billera [BB85, Theorem 2.1] that the flag vector of any Eulerian poset must satisfy the generalized Dehn-Sommerville equations of Example 5.10.

## 6. Even and odd subalgebras of $\mathcal{Q}$ Sym

Below we describe the even and odd subalgebras of the terminal combinatorial Hopf algebra $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$ in explicit terms. We continue to assume that $\operatorname{char}(\mathbb{k}) \neq 2$. We find that the odd subalgebra is the Hopf algebra introduced by Stembridge in [Ste97].

Let $\Pi_{+}$and $\Pi_{-}$denote the even and odd subalgebras of $\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right)$.
Proposition 6.1. Let $(\mathcal{H}, \zeta)$ be a combinatorial Hopf algebra and $\Psi:(\mathcal{H}, \zeta) \rightarrow\left(\mathcal{Q} S y m, \zeta_{\mathcal{Q}}\right)$ the unique morphism. Then

$$
\Psi\left(S_{+}(\mathcal{H}, \zeta)\right) \subseteq \Pi_{+} \quad \text { and } \quad \Psi\left(S_{-}(\mathcal{H}, \zeta)\right) \subseteq \Pi_{-} .
$$

Proof. This is a particular case of Proposition 5.8, part (e).
Corollary 6.2. Let $(\mathcal{H}, \zeta)$ be a combinatorial Hopf algebra and consider the unique morphism $\Psi:(\mathcal{H}, \zeta) \rightarrow\left(\mathcal{Q}\right.$ Sym,$\left.\zeta_{\mathcal{Q}}\right)$. If $\zeta$ is even then $\operatorname{Im}(\Psi) \subseteq \Pi_{+}$and if $\zeta$ is odd then $\operatorname{Im}(\Psi) \subseteq \Pi_{-}$.

## Combinatorial Hopf algebras

In addition, $\left(\Pi_{+}, \zeta_{\mathcal{Q}}\right)$ and $\left(\Pi_{-}, \zeta_{\mathcal{Q}}\right)$ are the terminal objects in the categories of even and odd combinatorial Hopf algebras, respectively.

Proof. If $\zeta$ is even then, by part (c) in Proposition $5.8, S_{+}(\mathcal{H}, \zeta)=\mathcal{H}$, so the conclusion follows from Proposition 6.1. The rest is similar.

A composition $\alpha=\left(a_{1}, \ldots, a_{k}\right)$ is said to be even (respectively, odd) if each part $a_{i}$ is even (respectively, odd). The empty composition () is the only composition that is both even and odd.

We describe $\Pi_{+}$in explicit terms.
Proposition 6.3. Assume that $\operatorname{char}(\mathbb{k}) \neq 2$. The set $\left\{M_{\alpha}\right\}_{\alpha \text { even }}$ is a linear basis for the even subalgebra $\Pi_{+}$of $\left(\mathcal{Q}\right.$ Sym,$\left.\zeta_{\mathcal{Q}}\right)$.

Proof. Recall that $\left(\zeta_{\mathcal{Q}}\right)_{n}=H_{n} \in \mathcal{N S}$ Sym, where $H_{\alpha}=M_{\alpha}^{*}$. We have

$$
\left(\bar{\zeta}_{\mathcal{Q}}\right)_{n}-\left(\zeta_{\mathcal{Q}}\right)_{n}= \begin{cases}-2 H_{n} & \text { if } n \text { is odd } \\ 0 & \text { if } n \text { is even } .\end{cases}
$$

Let $I$ be the ideal of $\mathcal{N}$ Sym generated by $\left\{H_{n}\right\}_{n \text { odd }}$. Then, by (3.6), $\left\{H_{\alpha}\right\}_{\alpha \text { not even }}$ is a linear basis of $I$, and by Theorem 5.3,

$$
\Pi_{+}=I^{\perp}=\{h \in \mathcal{Q S y m} \mid f(h)=0 \forall f \in I\} .
$$

Thus, $\left\{M_{\alpha}\right\}_{\alpha}$ even is a linear basis for $\Pi_{+}$.
We now turn to $\Pi_{-}$. An explicit description in terms of linear relations (the generalized DehnSommerville relations) has already been given in Example 5.10. We proceed to describe a linear basis. We make use of the morphisms $\Theta$ and $\Psi_{2}: \mathcal{Q S y m} \rightarrow \mathcal{Q}$ Sym introduced in Examples 4.7-4.9.

Proposition 6.4. Assume that $\operatorname{char}(\mathbb{k}) \neq 2$. The morphisms $\Theta: \mathcal{Q S y m} \rightarrow \mathcal{Q}$ Sym and $\Psi_{2}:$ $\mathcal{Q}$ Sym $\rightarrow \mathcal{Q}$ Sym satisfy
(a) $\left.\Psi_{2}\right|_{\Pi_{-}}=\left.\Theta\right|_{\Pi_{-}}$,
(b) $\Theta\left(\Pi_{-}\right)=\Pi_{-}$,
(c) $\Theta(\mathcal{Q S y m})=\Pi_{-}$.

Proof. By construction, $\Psi_{2}$ and $\Theta$ are the morphisms corresponding to the characters $\zeta_{\mathcal{Q}}^{2}$ and $\nu=\bar{\zeta}_{\mathcal{Q}}^{-1} \zeta_{\mathcal{Q}}$, respectively. Now, by Definition 5.7,

$$
\left.\bar{\zeta}_{\mathcal{Q}}^{-1}\right|_{\Pi_{-}}=\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{-}} .
$$

Therefore, $\left.\nu\right|_{\Pi_{-}}=\left.\zeta_{\mathcal{Q}}^{2}\right|_{\Pi_{-}}$and by uniqueness $\left.\Theta\right|_{\Pi_{-}}=\left.\Psi_{2}\right|_{\Pi_{-}}$.
Since $\nu$ is an odd character on $\mathcal{Q}$ Sym, we have, by Corollary 6.2,

$$
\Theta(\mathcal{Q S y m}) \subseteq \Pi_{-} .
$$

In particular, $\Theta\left(\Pi_{-}\right) \subseteq \Pi_{-}$. On the other hand, formula (4.5) shows that $\Psi_{2}: \mathcal{Q}$ Sym $\rightarrow \mathcal{Q}$ Sym is bijective (since $\operatorname{char}(k) \neq 2$ ), so by the above $\left.\Theta\right|_{\Pi_{-}}$is injective. Hence $\Theta\left(\Pi_{-}\right)=\Pi_{-}$and then also $\Theta(\mathcal{Q S y m})=\Pi_{-}$.

Given an odd composition $\beta$, set

$$
\begin{equation*}
\eta_{\beta}:=\sum_{\alpha \leqslant \beta} 2^{k(\alpha)} M_{\alpha} . \tag{6.1}
\end{equation*}
$$

The sum is over all compositions (not necessarily odd) smaller than $\beta$. Up to a sign, these are the elements introduced by Hsiao in [Hsi02, § 2].

Proposition 6.5. Assume that $\operatorname{char}(\mathbb{k}) \neq 2$. The odd subalgebra $\Pi_{-}$of $\left(\mathcal{Q}\right.$ Sym,$\left.\zeta_{\mathcal{Q}}\right)$ is Stembridge's Hopf algebra. The set $\left\{\eta_{\beta}\right\}_{\beta}$ odd is a linear basis for $\Pi_{-}$.

Proof. In Example 4.9 we identified $\Theta$ with the morphism defined by Stembridge in [Ste97]. Stembridge's Hopf algebra is defined as the image of $\Theta$. By Proposition 6.4, this image is $\Pi_{-}$.

By triangularity, the set $\left\{\eta_{\beta}\right\}_{\beta \text { odd }}$ is linearly independent. On the other hand, from the explicit form of $\Theta$ in (4.9), we see that this set spans $\operatorname{Im}(\Theta)=\Pi_{-}$.

Remark 6.6. The dimension of the $n$th homogeneous component of $\Pi_{+}$, i.e. the number of even compositions of $n$, is $2^{\frac{1}{2} n-1}$ if $n>0$ is even and 0 if $n$ is odd. The dimension of the $n$th homogeneous component of $\Pi_{-}$, i.e. the number of odd compositions of $n$, is the Fibonacci number $f_{n}$, where $f_{1}=f_{2}=1$ and $f_{n}=f_{n-1}+f_{n-2}$ for $n \geqslant 3$.

Remark 6.7. We provide a description for the dual of $\Pi_{-}$. According to Proposition 5.8,

$$
\Pi_{-}^{*}=\mathcal{N} S y m / I,
$$

where $I:=I\left(\bar{\zeta}_{\mathcal{Q}}, \zeta_{\mathcal{Q}}^{-1}\right)=I\left(\chi_{\mathcal{Q}}, \epsilon_{\mathcal{Q}}\right)$ is the ideal of $\mathcal{N}$ Sym generated by the elements

$$
\left(\bar{\zeta}_{\mathcal{Q}}\right)_{n}-\left(\zeta_{\mathcal{Q}}^{-1}\right)_{n}=(-1)^{n} H_{n}-\sum_{\alpha \models n}(-1)^{k(\alpha)} H_{\alpha}, n>0,
$$

or also by the elements

$$
\left(\chi_{\mathcal{Q}}\right)_{n}=\left(\chi_{\mathcal{Q}}\right)_{n}-\left(\epsilon_{\mathcal{Q}}\right)_{n}=\sum_{i=0}^{n}(-1)^{i} H_{(i, n-i)}, n>0
$$

Billera and Liu have shown that, if $\operatorname{char}(\mathbb{k}) \neq 2, I$ is in fact generated by the elements $\left(\chi_{\mathcal{Q}}\right)_{n}$ for $n$ even [BL00, Propositions 3.2 and 3.3]. From our point of view, this may be seen as follows. Consider the linear functional

$$
\omega_{\mathcal{Q}}:=\zeta_{\mathcal{Q}} \chi_{\mathcal{Q}}+\chi_{\mathcal{Q}} \bar{\zeta}_{\mathcal{Q}}=\zeta_{\mathcal{Q}} \bar{\zeta}_{\mathcal{Q}} \zeta_{\mathcal{Q}}+\bar{\zeta}_{\mathcal{Q}} \zeta_{\mathcal{Q}} \overline{\mathcal{S}}_{\mathcal{Q}}
$$

Then $\bar{\omega}_{\mathcal{Q}}=\bar{\zeta}_{\mathcal{Q}} \zeta_{\mathcal{Q}} \bar{\zeta}_{\mathcal{Q}}+\zeta_{\mathcal{Q}} \bar{\zeta}_{\mathcal{Q}} \zeta_{\mathcal{Q}}=\omega_{\mathcal{Q}}$, so $\left(\omega_{\mathcal{Q}}\right)_{n}=0$ for $n$ odd. Hence, if $n$ is odd,

$$
0=2\left(\chi_{\mathcal{Q}}\right)_{n}+\sum_{i=1}^{n}\left(\zeta_{\mathcal{Q}}\right)_{i}\left(\chi_{\mathcal{Q}}\right)_{n-i}+\sum_{i=0}^{n-1}\left(\chi_{\mathcal{Q}}\right)_{i}\left(\zeta_{\mathcal{Q}}\right)_{n-i}
$$

It follows by induction that the elements $\left(\chi_{\mathcal{Q}}\right)_{n}$ for odd $n$ belong to the ideal generated by the elements $\left(\chi_{\mathcal{Q}}\right)_{n}$ for even $n$.

## Canonical projections onto the odd and even subalgebras

Consider the canonical decomposition of Theorem 1.5 applied to the character $\zeta_{\mathcal{Q}}$ :

$$
\zeta_{\mathcal{Q}}=\left(\zeta_{\mathcal{Q}}\right)_{+}\left(\zeta_{\mathcal{Q}}\right)_{-}
$$

with $\left(\zeta_{\mathcal{Q}}\right)_{+}$even and $\left(\zeta_{\mathcal{Q}}\right)_{+}$odd. Let

$$
\Psi_{+}:\left(\mathcal{Q} \operatorname{Sym},\left(\zeta_{\mathcal{Q}}\right)_{+}\right) \rightarrow\left(\mathcal{Q} \operatorname{Sym}, \zeta_{\mathcal{Q}}\right) \quad \text { and } \quad \Psi_{-}:\left(\mathcal{Q} \operatorname{Sym},\left(\zeta_{\mathcal{Q}}\right)_{-}\right) \rightarrow\left(\mathcal{Q} \operatorname{Sym}, \zeta_{\mathcal{Q}}\right)
$$

be the unique morphisms of combinatorial Hopf algebras (Theorem 4.1). By Corollary 6.2,

$$
\begin{equation*}
\operatorname{Im}\left(\Psi_{+}\right) \subseteq \Pi_{+} \quad \text { and } \quad \operatorname{Im}\left(\Psi_{-}\right) \subseteq \Pi_{-} . \tag{6.2}
\end{equation*}
$$

We can in fact show that $\Psi_{+}$and $\Psi_{-}$are projections onto $\Pi_{+}$and $\Pi_{-}$, as follows.
Proposition 6.8. With the above notation,
(a) $\operatorname{Im}\left(\Psi_{+}\right)=\Pi_{+}$and $\operatorname{Im}\left(\Psi_{-}\right)=\Pi_{-}$;
(b) $\left.\Psi_{+}\right|_{\Pi_{+}}=\left.\mathrm{id}\right|_{\Pi_{+}}$and $\left.\Psi_{-}\right|_{\Pi_{-}}=\left.\mathrm{id}\right|_{\Pi_{-}}$;
(c) $\left.\Psi_{+}\right|_{\Pi_{-}}=\left.\epsilon\right|_{\Pi_{-}}$and $\left.\Psi_{-}\right|_{\Pi_{+}}=\left.\epsilon\right|_{\Pi_{+}}$;
(d) $\Psi_{+} \Psi_{-}=\mathrm{id}$ (convolution product in $\left.\operatorname{End}(\mathcal{Q S y m})\right)$.

Proof. By definition of even and odd subalgebras (Definition 5.7), $\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{+}}$is even and $\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{-}}$is odd. Hence, by uniqueness of the decomposition of Theorem 1.5,

$$
\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{+}}=\left.\left(\zeta_{\mathcal{Q}}\right)_{+}\right|_{\Pi_{+}},\left.\quad \zeta_{\mathcal{Q}}\right|_{\Pi_{-}}=\left.\left(\zeta_{\mathcal{Q}}\right)_{-}\right|_{\Pi_{-}}, \quad \text { and }\left.\quad\left(\zeta_{\mathcal{Q}}\right)_{+}\right|_{\Pi_{-}}=\left.\epsilon\right|_{\Pi_{-}},\left.\quad\left(\zeta_{\mathcal{Q}}\right)_{-}\right|_{\Pi_{+}}=\left.\epsilon\right|_{\Pi_{+}}
$$

Assertions (b) and (c) follow from here, in view of uniqueness in Theorem 4.1. Together with (6.2), assertion (b) implies assertion (a).

To obtain assertion (d) it suffices to show that $\zeta_{\mathcal{Q}} \circ\left(\Psi_{+} \Psi_{-}\right)=\zeta_{\mathcal{Q}}$, again by Theorem 4.1. Now, since $\zeta_{\mathcal{Q}}$ is a morphism of algebras, precomposing with $\zeta_{\mathcal{Q}}$ preserves convolution products. Hence,

$$
\zeta_{\mathcal{Q}} \circ\left(\Psi_{+} \Psi_{-}\right)=\left(\zeta_{\mathcal{Q}} \circ \Psi_{+}\right)\left(\zeta_{\mathcal{Q}} \circ \Psi_{-}\right)=\left(\zeta_{\mathcal{Q}}\right)_{+}\left(\zeta_{\mathcal{Q}}\right)_{-}=\zeta_{\mathcal{Q}}
$$

by definition of $\Psi_{ \pm}$and $\left(\zeta_{\mathcal{Q}}\right)_{ \pm}$. The proof is complete.
Proposition 6.9. The map $\Theta$ and the projection $\Psi_{-}$are related as follows:
(a) $\Theta \circ \Psi_{-}=\Theta=\Psi_{-} \circ \Theta$;
(b) $\operatorname{Im}\left(\Psi_{-}\right)=\operatorname{Im}(\Theta)=\Pi_{-}$;
(c) $\operatorname{ker}\left(\Psi_{-}\right)=\operatorname{ker}(\Theta)$.

Proof. Assertion (b) is part of Propositions 6.4 and 6.8. The fact that $\Psi_{-} \circ \Theta=\Theta$ also follows from those propositions, since $\left.\Psi_{-}\right|_{\operatorname{Im}(\Theta)}=\left.\mathrm{id}\right|_{\operatorname{Im}(\Theta)}$.

By our construction of $\Theta$ and Remark 1.6,

$$
\zeta_{\mathcal{Q}} \circ \Theta=\nu_{\mathcal{Q}}=\left(\left(\zeta_{\mathcal{Q}}\right)_{-}\right)^{2}
$$

Hence,

$$
\zeta_{\mathcal{Q}} \circ \Theta \circ \Psi_{-}=\left(\left(\zeta_{\mathcal{Q}}\right)_{-}\right)^{2} \circ \Psi_{-}=\left(\left(\zeta_{\mathcal{Q}}\right)_{-} \circ \Psi_{-}\right)^{2}=\left(\zeta_{\mathcal{Q}} \circ \Psi_{-}\right)^{2}=\left(\left(\zeta_{\mathcal{Q}}\right)_{-}\right)^{2},
$$

since $\operatorname{Im}\left(\Psi_{-}\right)=\Pi_{-}$and $\left.\left(\zeta_{\mathcal{Q}}\right)_{-}\right|_{\Pi_{-}}=\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{-}}$.
Thus, $\zeta_{\mathcal{Q}} \circ \Theta=\zeta_{\mathcal{Q}} \circ \Theta \circ \Psi_{-}$and, by uniqueness in Theorem 4.1, $\Theta \circ \Psi_{-}=\Theta$. This completes the proof of assertion (a).

From assertion (a) it follows that $\operatorname{ker}\left(\Psi_{-}\right) \subseteq \operatorname{ker}(\Theta)$, which with assertion (b) implies assertion (c).

We conclude with an important result that states that $\mathcal{Q S y m}$ is the product of its even and odd subalgebras in the category of graded connected Hopf algebras.

Theorem 6.10. Let $\mathcal{H}$ be a graded connected Hopf algebra and

$$
\alpha_{+}: \mathcal{H} \rightarrow \Pi_{+} \quad \text { and } \quad \alpha_{-}: \mathcal{H} \rightarrow \Pi_{-}
$$

be two morphisms of graded Hopf algebras. Then there is a unique morphism of graded Hopf algebras $\alpha: \mathcal{H} \rightarrow \mathcal{Q}$ Sym such that the following diagram commutes:


Proof. Define two characters on $\mathcal{H}$ by

$$
\zeta_{+}:=\zeta_{\mathcal{Q}} \circ \alpha_{+} \quad \text { and } \quad \zeta_{-}:=\zeta_{\mathcal{Q}} \circ \alpha_{-} .
$$

In other words, $\zeta_{ \pm}=\alpha_{ \pm}^{*}\left(\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{ \pm}}\right)$. Since $\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{+}}$is even and $\left.\zeta_{\mathcal{Q}}\right|_{\Pi_{-}}$is odd, $\zeta_{+}$is an even character of $\mathcal{H}$ and $\zeta_{-}$is an odd character of $\mathcal{H}$. Define a third character on $\mathcal{H}$ by

$$
\zeta:=\zeta_{+} \zeta_{-} .
$$

Let $\alpha: \mathcal{H} \rightarrow \mathcal{Q} S y m$ be the unique morphism of graded Hopf algebras such that $\zeta_{\mathcal{Q}} \circ \alpha=\zeta$ (Theorem 4.1). Then, we have

$$
\zeta=\alpha^{*}\left(\zeta_{\mathcal{Q}}\right)=\alpha^{*}\left(\left(\zeta_{\mathcal{Q}}\right)_{+}\left(\zeta_{\mathcal{Q}}\right)_{-}\right)=\alpha^{*}\left(\left(\zeta_{\mathcal{Q}}\right)_{+}\right) \alpha^{*}\left(\left(\zeta_{\mathcal{Q}}\right)_{-}\right)
$$

This is another decomposition of $\zeta$ as a product of an even and an odd character. By Theorem 1.5 we must have

$$
\zeta_{ \pm}=\alpha^{*}\left(\left(\zeta_{\mathcal{Q}}\right)_{ \pm}\right)=\left(\zeta_{\mathcal{Q}}\right)_{ \pm} \circ \alpha
$$

On the other hand, by definition of $\Psi_{+}$and $\Psi_{-},\left(\zeta_{\mathcal{Q}}\right)_{ \pm}=\zeta_{\mathcal{Q}} \circ \Psi_{ \pm}$. Therefore,

$$
\zeta_{\mathcal{Q}} \circ \Psi_{ \pm} \circ \alpha=\left(\zeta_{\mathcal{Q}}\right)_{ \pm} \circ \alpha=\zeta_{ \pm}=\zeta_{\mathcal{Q}} \circ \alpha_{ \pm} .
$$

It follows from Theorem 4.1 that $\Psi_{ \pm} \circ \alpha=\alpha_{ \pm}$, i.e. diagram (6.3) commutes.
Suppose $\tilde{\alpha}: \mathcal{H} \rightarrow \mathcal{Q}$ Sym is another morphism of graded Hopf algebras such that $\Psi_{ \pm} \circ \tilde{\alpha}=\alpha_{ \pm}$. In the derivation below, we make use of the fact that $\Psi_{+} \Psi_{-}=\mathrm{id}$ (Proposition 6.8):

$$
\begin{aligned}
\zeta_{\mathcal{Q}} \circ \tilde{\alpha} & =\zeta_{\mathcal{Q}} \circ\left(\Psi_{+} \Psi_{-}\right) \circ \tilde{\alpha}=\zeta_{\mathcal{Q}} \circ\left(\left(\Psi_{+} \circ \tilde{\alpha}\right)\left(\Psi_{-} \circ \tilde{\alpha}\right)\right) \\
& =\zeta_{\mathcal{Q}} \circ\left(\alpha_{+} \alpha_{-}\right)=\left(\zeta_{\mathcal{Q}} \circ \alpha_{+}\right)\left(\zeta_{\mathcal{Q}} \circ \alpha_{-}\right)=\zeta_{+} \zeta_{-}=\zeta=\zeta_{\mathcal{Q}} \circ \alpha .
\end{aligned}
$$

From Theorem 4.1 we deduce $\tilde{\alpha}=\alpha$.
Remark 6.11. The Hilbert series (see § 8) of $\mathcal{Q S y m}, \Pi_{+}$, and $\Pi_{-}$are

$$
\mathcal{Q S y m}(x)=\frac{1-x}{1-2 x}, \quad \Pi_{+}(x)=\frac{1-x^{2}}{1-2 x^{2}}, \quad \text { and } \quad \Pi_{-}(x)=\frac{1-x^{2}}{1-x-x^{2}} .
$$

The latter two expressions follow from Propositions 6.3 and 6.5. Note that

$$
\frac{1}{\mathcal{Q} \operatorname{Sym}(x)}=\frac{1}{\Pi_{+}(x)}+\frac{1}{\Pi_{-}(x)}-1 .
$$

This may also be seen as a consequence of Theorem 6.10. In fact, it follows from this theorem that $\mathcal{N S y m}=(\mathcal{Q S y m})^{*}$ is the free product of the algebras $\left(\Pi_{+}\right)^{*}$ and $\left(\Pi_{-}\right)^{*}$, and it is a general fact that the Hilbert series of a free product $A=A_{1} * A_{2}$ of two graded connected algebras is related to the Hilbert series of the factors by means of

$$
\begin{equation*}
\frac{1}{A(x)}=\frac{1}{A_{1}(x)}+\frac{1}{A_{2}(x)}-1 . \tag{6.4}
\end{equation*}
$$

## 7. Even and odd subalgebras of Sym

We describe the even and odd subalgebras of the combinatorial Hopf algebra of symmetric functions $\left(S y m, \zeta_{S}\right)$. We find that the odd subalgebra is the Hopf algebra of Schur $Q$-functions [Mac95, III.8].

Let $\lambda=\left(l_{1}, \ldots, l_{k}\right)$ be a partition of $n$. As for compositions, we write $|\lambda|=n$ and $k(\lambda)=k$. Recall the power sum symmetric functions $p_{\lambda}$, defined by

$$
\begin{equation*}
p_{n}:=m_{n} \quad \text { and } \quad p_{\lambda}:=p_{l_{1}} \cdots p_{l_{k}} \tag{7.1}
\end{equation*}
$$

As for compositions, we say that a partition is even (odd) if all its parts are even (odd). For each odd partition $\lambda$, define an element

$$
\begin{equation*}
\eta_{\lambda}:=\sum_{s(\alpha)=\lambda} \eta_{\alpha} \tag{7.2}
\end{equation*}
$$

where $\eta_{\alpha}$ is as in (6.1) and $s(\alpha)$ as in (3.4).

Proposition 7.1. Assume $\mathbb{k}=\mathbb{Q}$. The sets $\left\{p_{\lambda}\right\}_{\lambda}$ odd and $\left\{\eta_{\lambda}\right\}_{\lambda}$ odd are linear bases for the odd subalgebra of $\left(S y m, \zeta_{S}\right)$.
Proof. Consider first the elements $\eta_{\lambda}$. By part (f) in Proposition 5.8 applied to Sym $\hookrightarrow \mathcal{Q}$ Sym,

$$
S_{-}\left(\text {Sym }, \zeta_{S}\right)=S_{-}\left(\mathcal{Q S y m}, \zeta_{\mathcal{Q}}\right) \cap \text { Sym } .
$$

The set $\left\{\eta_{\alpha}\right\}_{\alpha}$ odd is a basis for $S_{-}\left(\mathcal{Q} S y m, \zeta_{\mathcal{Q}}\right)$, by Proposition 6.5 . It follows readily from (3.4), (6.1), and (7.2) that the set $\left\{\eta_{\lambda}\right\}_{\lambda}$ odd is a basis for $S_{-}\left(S y m, \zeta_{S}\right)$.

Note that $\eta_{2 n+1}=m_{2 n+1}=p_{2 n+1}$. Hence, by (7.1), and since $S_{-}\left(S y m, \zeta_{S}\right)$ is a subalgebra, $p_{\lambda} \in S_{-}\left(\right.$Sym,$\left.\zeta_{S}\right)$ for each odd partition $\lambda$. Since the set $\left\{p_{\lambda}\right\}_{\lambda}$ odd is linearly independent and has the same number of elements in each homogeneous dimension as the set $\left\{\eta_{\lambda}\right\}_{\lambda}$ odd , it must also be a linear basis for $S_{-}\left(\right.$Sym,$\left.\zeta_{S}\right)$.

Remark 7.2. It is easy to see that

$$
\zeta_{S}\left(p_{\lambda}\right)=1, \quad \bar{\zeta}_{S}\left(p_{\lambda}\right)=(-1)^{|\lambda|}, \quad \text { and } \quad \zeta_{S}^{-1}\left(p_{\lambda}\right)=(-1)^{k(\lambda)} .
$$

One may use these to show directly that $\left\{p_{\lambda}\right\}_{\lambda}$ odd is a basis for $S_{-}\left(S y m, \zeta_{S}\right)$.
Proposition 7.3. Assume $\mathbb{k}=\mathbb{Q}$. The sets $\left\{p_{\lambda}\right\}_{\lambda}$ even and $\left\{m_{\lambda}\right\}_{\lambda \text { even }}$ are linear bases for the even subalgebra of $\left(S y m, \zeta_{S}\right)$.
Proof. By part (f) in Proposition 5.8 applied to Sym $\hookrightarrow \mathcal{Q}$ Sym,

$$
S_{+}\left(\text {Sym }, \zeta_{S}\right)=S_{+}\left(\mathcal{Q} \text { Sym }, \zeta_{\mathcal{Q}}\right) \cap \text { Sym. }
$$

According to Proposition 6.3, the set $\left\{M_{\alpha}\right\}_{\alpha}$ even is a linear basis for $S_{+}\left(\mathcal{Q} S y m, \zeta_{\mathcal{Q}}\right)$. It is then clear from (3.4) that the set $\left\{m_{\lambda}\right\}_{\lambda \text { even }}$ is a basis for $S_{+}\left(S y m, \zeta_{S}\right)$. Recall that $p_{2 n}=m_{2 n}$. As in the proof of Proposition 7.1, it follows that the set $\left\{p_{\lambda}\right\}_{\lambda}$ even is a linear basis for $S_{+}\left(S y m, \zeta_{S}\right)$.
Remark 7.4. Proposition 7.1 shows that the odd subalgebra of $\left(S y m, \zeta_{S}\right)$ is the Hopf algebra of Schur $Q$-functions, as defined in [Mac95, III.8].

As seen in the above proof, $S_{-}\left(S y m, \zeta_{S}\right)=S_{-}\left(\mathcal{Q} S y m, \zeta_{\mathcal{Q}}\right) \cap$ Sym. This says that (if $\left.\mathbb{k}=\mathbb{Q}\right)$ the intersection of Stembridge's Hopf algebra $\Pi_{-}$with Sym is the Hopf algebra of Schur $Q$-functions, a known result from [Ste97, Theorem 3.8].

Recall that the graded Hopf algebra Sym is self-dual (3.8). Thus, the components of a character on Sym are elements of Sym itself, and Proposition 5.9 relates even and odd characters on Sym to the even and odd subalgebras of $\left(S y m, \zeta_{S}\right)$. Consider the canonical odd character $\nu_{S}$ and the Euler character $\chi_{S}$. Since Sym is cocommutative, $\chi_{S}$ is even (Example 1.3). Thus, Proposition 5.9 guarantees that the components of $\nu_{S}$ belong to $S_{-}\left(S y m, \zeta_{S}\right)$ and those of $\chi_{S}$ to $S_{+}\left(S y m, \zeta_{S}\right)$. Let $e_{n}$ be the elementary symmetric functions. The components of the canonical characters of Sym are:

$$
\begin{aligned}
\left(\zeta_{S}\right)_{n} & =h_{n}=\sum_{\lambda \vdash n} m_{\lambda}, \\
\left(\zeta_{S}^{-1}\right)_{n} & =(-1)^{n} e_{n}, \\
\left(\nu_{S}\right)_{n} & =\sum_{i=0}^{n} e_{i} h_{n-i}, \\
\left(\chi_{S}\right)_{n} & =\sum_{i=0}^{n}(-1)^{i} h_{(i, n-i)}= \begin{cases}\sum_{\substack{\lambda \vdash n \\
\lambda \text { even } \\
0}} m_{\lambda} & \text { if } n \text { is even, } \\
\text { if } n \text { is odd. } .\end{cases}
\end{aligned}
$$

In particular, we see that the components of $\nu_{S}$ are precisely the Schur $Q$-functions $q_{n}$, as defined in [Mac95, III.8, formula (8.1)].

Remark 7.5. The decomposition of the Hopf algebra of quasi-symmetric functions as the categorical product of its even and odd Hopf subalgebras (Theorem 6.10) admits an analog for symmetric functions: Sym is the product of its even and odd subalgebras in the category of cocommutative Hopf algebras. In this category, the product is simply the tensor product of Hopf algebras. Thus,

$$
\begin{equation*}
\text { Sym } \cong S_{+}\left(S y m, \zeta_{S}\right) \otimes S_{-}\left(\text {Sym }, \zeta_{S}\right) \tag{7.3}
\end{equation*}
$$

The proof of this fact is completely analogous to that of Theorem 6.10. It also follows at once from the explicit descriptions for $S_{ \pm}\left(S y m, \zeta_{S}\right)$ in Propositions 7.1 and 7.3.

In terms of Hilbert series, the decomposition (7.3) boils down to

$$
\prod_{n \geqslant 1} \frac{1}{1-x^{n}}=\prod_{n \geqslant 1} \frac{1}{1-x^{2 n}} \prod_{n \geqslant 1} \frac{1}{1-x^{2 n-1}} .
$$

Since Sym is commutative, (7.3) is also a coproduct decomposition in the category of commutative Hopf algebras. In fact, this decomposition is self-dual.

## 8. The odd subalgebras of other combinatorial Hopf algebras

Symmetric, quasi-symmetric, and non-commutative symmetric functions (§ 3) are related by the following commutative diagram of graded Hopf algebras.


The Hopf algebra $\mathfrak{S}$ Sym has linear bases indexed by all permutations of $[n], n \geqslant 0$, and was introduced by Malvenuto and Reutenauer [Ma194, MR95]. The Hopf algebra Y Sym has linear bases indexed by planar binary trees and was introduced by Loday and Ronco [LR98, LR02]. See also [AS05, AS04] for a detailed study of these Hopf algebras. Both $\mathfrak{S}$ Sym and $\mathcal{Y}$ Sym are self-dual Hopf algebras (in the graded sense). In diagram (8.1), duality acts as reflection across the middle horizontal line (not just on objects but also on morphisms).

In $\S \S 6$ and 7 we calculated the even and odd subalgebras of $\mathcal{Q} S y m$ and Sym. In this section we calculate the odd subalgebras of $\mathcal{N S y m}, \mathfrak{S}$ Sym and $\mathcal{Y}$ Sym. The even subalgebras may be calculated by the same methods. We view these as combinatorial Hopf algebras via the pull-back of the canonical character $\zeta_{\mathcal{Q}}$ of $\mathcal{Q}$ Sym; therefore, (8.1) is a commutative diagram of morphisms of combinatorial Hopf algebras.

In this section, we use $\mathcal{O Q}$ to denote the odd subalgebra of $\left(\mathcal{Q}\right.$ Sym, $\left.\zeta_{\mathcal{Q}}\right)$ (instead of $S_{-}(\mathcal{Q}$ Sym, $\left.\zeta_{\mathcal{Q}}\right)$ ), and $\mathcal{I \mathcal { Q }}$ to denote the odd ideal $I_{-}\left(\mathcal{Q}\right.$ Sym, $\left.\zeta_{\mathcal{Q}}\right)$. Thus, $\mathcal{O Q}$ is a Hopf subalgebra of $\mathcal{Q}$ Sym, $\mathcal{I} \mathcal{Q}$ is a Hopf ideal of $\mathcal{N S}$ Sym, and by Proposition 5.8 part (a),

$$
(\mathcal{O Q})^{*}=\mathcal{N S y m} / \mathcal{I} \mathcal{Q} .
$$

Similarly, we use $\mathcal{O S}$ and $\mathcal{I S}, \mathcal{O N}$ and $\mathcal{I N}, \mathcal{O S}$ and $\mathcal{I S}$, and $\mathcal{O Y}$ and $\mathcal{I Y}$ for the odd subalgebras and ideals associated to the combinatorial Hopf algebras Sym, NSym, Y Sym, and SSym.

If $V=\bigoplus_{n \geqslant 0} V_{n}$ is a graded vector space and each $V_{n}$ is finite-dimensional, we let

$$
V(x):=\sum_{n \geqslant 0} \operatorname{dim} V_{n} x^{n}
$$

denote the corresponding Hilbert series.

From Proposition 6.5 and Remark 6.6 we know that

$$
\begin{equation*}
\mathcal{O} \mathcal{Q}(x)=\frac{1-x^{2}}{1-x-x^{2}} \tag{8.2}
\end{equation*}
$$

From Proposition 7.1 it follows that

$$
\begin{equation*}
\mathcal{O} S(x)=\prod_{n \geqslant 0} \frac{1}{1-x^{2 n+1}} . \tag{8.3}
\end{equation*}
$$

Below we provide formulas for the Hilbert series of $\mathcal{O N}, \mathcal{O S}$, and $\mathcal{O Y}$.

## The odd subalgebra of $\mathcal{N S y m}$

We describe the graded dual of $\mathcal{O} \mathcal{N}$. This is a quotient Hopf algebra of $(\mathcal{N} \text { Sym })^{*}=\mathcal{Q}$ Sym .
Our derivation is based on the following simple fact. Let $V$ be a vector space and $S(V)$ the free commutative algebra on $V$ (the symmetric algebra). Let $W$ be another vector space and consider the inclusion $S(V) \hookrightarrow S(V \oplus W)$ induced by the canonical map $V \hookrightarrow V \oplus W$. Let $I$ be an ideal of $S(V)$ and $J$ the ideal of $S(V \oplus W)$ generated by $I$. Then there are canonical isomorphisms of algebras

$$
\begin{equation*}
\frac{S(V \oplus W)}{J}=\frac{S(V) \otimes S(W)}{I \otimes S(W)}=\frac{S(V)}{I} \otimes S(W) . \tag{8.4}
\end{equation*}
$$

The algebra of symmetric functions is freely generated, as a commutative algebra, by the elements $m_{n}, n \geqslant 1$ [Mac95, I.2]. It is also known that the algebra of quasi-symmetric functions is freely generated, as a commutative algebra over $\mathbb{Q}$, by the elements $M_{\alpha}$ indexed by Lyndon compositions $\alpha$ [Hof00, Theorem 2.6, Example 6.1]. The latter set of generators contains the former, as all compositions with one part are Lyndon and $M_{(n)}=m_{n}$. (A similar result is [MR95, Corollary 2.2].)

Let $V$ be the vector subspace of Sym spanned by $\left\{m_{n}\right\}_{n \geqslant 1}$ and $W$ the subspace of $\mathcal{Q}$ Sym spanned by the elements $M_{\alpha}$ where $\alpha$ runs over the set of Lyndon compositions with two or more parts. Thus, as algebras,

$$
\begin{equation*}
\text { Sym }=S(V), \quad \mathcal{Q} \text { Sym }=S(V \oplus W)=S(V) \otimes S(W), \tag{8.5}
\end{equation*}
$$

and the inclusion Sym $\hookrightarrow \mathcal{Q S y m}$ is induced by the canonical map $V \hookrightarrow V \oplus W$.
Since the map $\mathcal{N}$ Sym $\rightarrow$ Sym is a morphism of combinatorial Hopf algebras, $\mathcal{I N}$ is the ideal of $(\mathcal{N} \text { Sym })^{*}=\mathcal{Q}$ Sym generated by $\mathcal{I} S$ (by part (e) in Proposition 5.8). Therefore, applying (8.4) with $I=\mathcal{I} S$ and $J=\mathcal{I N}$ and making use of part (a) in Proposition 5.8 we obtain

$$
\begin{equation*}
(\mathcal{O N})^{*}=\frac{\mathcal{Q S y m}}{\mathcal{I N}}=\frac{\text { Sym }}{\mathcal{I} S} \otimes S(W)=(\mathcal{O} S)^{*} \otimes S(W) \tag{8.6}
\end{equation*}
$$

(we used $(\mathcal{N} \text { Sym })^{*}=\mathcal{Q S y m}$ and $(\text { Sym })^{*}=$ Sym $)$.
For $n \geqslant 1$, the number of Lyndon compositions of $n$ is [Slo94, Sequence A059966]

$$
\ell_{n}:=\frac{1}{n} \sum_{d \mid n} \mu\left(\frac{n}{d}\right)\left(2^{d}-1\right),
$$

where $\mu$ is the classical (number-theoretic) Möbius function. Therefore,

$$
S(W)(x)=\prod_{n \geqslant 1} \frac{1}{\left(1-x^{n}\right)^{\ell_{n}-1}}
$$

and from (8.3) and (8.6) we deduce

$$
\mathcal{O} \mathcal{N}(x)=\prod_{n \geqslant 1} \frac{1}{\left(1-x^{n}\right)^{a_{n}}}, \quad \text { where } a_{n}= \begin{cases}\ell_{n} & \text { if } n \text { is odd } \\ \ell_{n}-1 & \text { if } n \text { is even } .\end{cases}
$$

Thus,

$$
\mathcal{O} \mathcal{N}(x)=1+x+x^{2}+3 x^{3}+5 x^{4}+11 x^{5}+22 x^{6}+44 x^{7}+\cdots .
$$

Note that (8.5) and (8.6) also imply that

$$
\frac{\mathcal{O N}(x)}{\mathcal{O} S(x)}=\frac{\mathcal{N S S y m}(x)}{\operatorname{Sym}(x)} .
$$

## The odd subalgebras of $\mathfrak{S S y m}$ and $\mathcal{Y}$ Sym

We describe the graded dual of $\mathcal{O S}$ by a derivation similar to the one in the previous section.
Let $V$ be a vector space and $T(V)$ the free algebra on $V$ (the tensor algebra). Let $W$ be another vector space and consider the inclusion $T(V) \hookrightarrow T(V \oplus W)$ induced by the canonical map $V \hookrightarrow$ $V \oplus W$. Let $I$ be an ideal of $T(V)$ and $J$ the ideal of $T(V \oplus W)$ generated by $I$. There is a canonical isomorphism of algebras

$$
\begin{equation*}
\frac{T(V \oplus W)}{J}=\frac{T(V)}{I} * T(W) \tag{8.7}
\end{equation*}
$$

where $*$ denotes the free product of algebras.
The algebra of non-commutative symmetric functions is freely generated by the elements $H_{n}$, $n \geqslant 1$. According to [AS05, Theorem 6.1, Remark 6.2], the algebra ( $\mathfrak{S}$ Sym $)^{*}$ is freely generated by certain elements indexed by permutations with no global descents. Moreover, it follows from [AS05, Theorem 7.3] that the inclusion $\mathcal{N} S y m \hookrightarrow(\mathfrak{S} S y m)^{*}$ sends $H_{n}$ to the basis element indexed by the identity permutation of $n$ (which has no global descents). Thus, there are spaces $V$ and $W$ such that

$$
\begin{equation*}
\mathcal{N S y m}=T(V), \quad(\mathfrak{S S y m})^{*}=T(V \oplus W)=T(V) * T(W) \tag{8.8}
\end{equation*}
$$

and the inclusion $\mathcal{N S y m} \hookrightarrow(\mathfrak{S} \text { Sym })^{*}$ is induced by $V \hookrightarrow V \oplus W$. The space $W$ has a basis indexed by permutations that have no global descents and are different from the identity.

Since the map $\mathfrak{S S y m} \rightarrow \mathcal{Q}$ Sym is a morphism of combinatorial Hopf algebras, $\mathcal{I S}$ is the ideal of (SSym)* generated by $\mathcal{I Q}$ (by part (e) in Proposition 5.8). Therefore, applying (8.7) with $I=\mathcal{I} \mathcal{Q}$ and $J=\mathcal{I} \mathfrak{S}$ we obtain

$$
\begin{equation*}
(\mathcal{O S})^{*}=\frac{(\mathfrak{S S y m})^{*}}{\mathcal{I} \mathfrak{S}}=\frac{\mathcal{N} S y m}{\mathcal{I} \mathcal{Q}} * T(W)=(\mathcal{O Q})^{*} * T(W) \tag{8.9}
\end{equation*}
$$

Recall that the Hilbert series of a free product is related to the Hilbert series of the factors by means of (6.4). Applying this to (8.8) and (8.9) we deduce

$$
\frac{1}{\mathcal{O S}(x)}-\frac{1}{\mathcal{O} \mathcal{Q}(x)}=\frac{1}{\mathfrak{S} \operatorname{Sym}(x)}-\frac{1}{\mathcal{Q} \operatorname{Sym}(x)}
$$

This reduces to

$$
\frac{1}{\mathcal{O S}(x)}=\frac{1}{\sum_{n \geqslant 0} n!x^{n}}+\frac{x^{2}}{1-x^{2}},
$$

from which

$$
\mathcal{O S}(x)=1+x+x^{2}+4 x^{3}+19 x^{4}+105 x^{5}+660 x^{6}+\cdots
$$

The Hopf algebra $(\mathcal{Y} \text { Sym })^{*}$ is also free on a set of generators containing the generators of $\mathcal{N}$ Sym, according to the results of [AS04]. Therefore analogous considerations apply and we obtain

$$
\frac{1}{\mathcal{O Y}(x)}-\frac{1}{\mathcal{O} \mathcal{Q}(x)}=\frac{1}{\mathcal{Y} \operatorname{Sym}(x)}-\frac{1}{\mathcal{Q} \operatorname{Sym}(x)}
$$
